
HOUSE BILL No. 1113

DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-6-2; IC 34-28-7; IC 34-30-20.2.

Synopsis: Firearms in locked vehicles or secure locations. Prohibits a person from adopting or enforcing a policy or rule that would prohibit or have the effect of prohibiting an individual who has a valid state issued permit from legally possessing a firearm that is: (1) locked in the individual's vehicle while the vehicle is in or on the person's property; or (2) stored at a location in or on the person's property that is secure and allows the individual to check the firearm in and out when entering and leaving the person's property. Provides that the prohibition against such a policy or rule does not apply to firearm possession: (1) on school property, on property used by a school for a school function, or on a school bus; (2) on certain child care and shelter facility property; (3) on penal facility property; or (4) that would violate federal law. Provides that a person who, in compliance with the prohibition, does not adopt or enforce such a policy or rule is not liable for resulting injury or damage. Authorizes a civil action for damages, costs, attorney's fees, and injunctive relief to remedy a violation of the prohibition. Deletes an outdated reference.

A BILL FOR AN ACT to amend the Indiana Code concerning civil procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 34-6-2-46.7 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2009]: Sec. 46.7. "Firearm", for
3 purposes of **IC 34-28-7 and** IC 34-30-20, has the meaning set forth in
4 IC 35-47-1-5.

5 SECTION 2. IC 34-6-2-49 IS AMENDED TO READ AS
6 FOLLOWS [EFFECTIVE JULY 1, 2009]: Sec. 49. (a) "Governmental

- 37 (5) an agency of the state or a political subdivision; or
- 38 (6) a group of such persons acting in concert.

30 **Chapter 7. Possession of Firearms on Certain Property**

31 **Sec. 1. This chapter applies only to possession of a firearm by an**
 32 **individual who:**

- 33 (1) **has a valid state issued license to possess the firearm for**
- 34 **purposes of protecting life and property; or**
- 35 (2) **is exempt from licensing under IC 35-47-2-2.**

36 **Sec. 2. (a) Notwithstanding any other law and except as**
 37 **provided in subsection (b), a person may not adopt or enforce a**
 38 **policy or rule that prohibits or has the effect of prohibiting an**
 39 **individual from possessing a firearm that is:**

- 40 (1) **locked in the individual's vehicle while the vehicle is in or**
- 41 **on the person's property; or**
- 42 (2) **stored at a location in or on the person's property that:**

1 (A) is secured by the person; and
 2 (B) allows the individual to check the firearm in and out
 3 when entering and leaving the person's property.
 4 (b) Subsection (a) does not apply to an individual who possesses
 5 a firearm:
 6 (1) in or on school property, in or on property that is being
 7 used by a school for a school function, or on a school bus in
 8 violation of IC 20-33-8-16 or IC 35-47-9;
 9 (2) on the property of:
 10 (A) a child caring institution;
 11 (B) an emergency shelter care child caring institution;
 12 (C) a private secure facility;
 13 (D) a group home; or
 14 (E) an emergency shelter care group home;
 15 in violation of 465 IAC 2-9-80(b)(3), 465 IAC 2-10-79(b)(3),
 16 465 IAC 2-11-80(b)(3), 465 IAC 2-12-78(b)(3), or 465
 17 IAC 2-13-77(b)(3);
 18 (3) on the property of a penal facility (as defined in

 21 **Sec. 3. (a) An individual may bring a civil action to enforce**
 22 **section 2 of this chapter.**
 23 (b) In an action brought under subsection (a), if a person is
 24 found to have violated section 2(a) of this chapter, the court may
 25 do the following:
 26 (1) Award:
 27 (A) actual damages; and
 28 (B) court costs and attorney's fees;
 29 to the prevailing individual.
 30 (2) Enjoin further violations of this chapter.
 31 **Sec. 4. This chapter does not limit a person's rights or remedies**
 32 **under any other state or federal law.**
 33 **Sec. 5. A person is not liable for any injury or damage resulting**
 34 **from the person's compliance with section 2(a) of this chapter.**

 38 **Chapter 20.2. Immunity for Complying With Law Prohibiting**
 39 **Adoption or Enforcement of Policy Prohibiting Possession of**
 40 **Firearms on Certain Property**
 41 **Sec. 1. A person who complies with IC 34-28-7-2 is immune**
 42 **from liability in accordance with IC 34-28-7-5.**
