# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1181 be amended to read as follows:

- 1 Page 30, between lines 1 and 2, begin a new paragraph and insert:
- 2 "SECTION 40. IC 36-6-9 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2010]:
- 5 **Chapter 9. Employment of Relatives**
- 6 **Sec. 1. This section does not apply to an individual who:**
- 7 (1) is a contractor or employed by a contractor for the design
- 8 or construction of a township public works project;
- 9 (2) is a vendor or employed by a vendor for a township
- 10 purchase of supplies;
- 11 (3) is a vendor or employed by a vendor for a township
- 12 purchase of mowing services or property maintenance
- 13 services; or
- 14 (4) is a member of a paid fire department or a volunteer fire
- 15 department that renders fire protection services to the
- 16 township.
- 17 **Sec. 2. (a) As used in this chapter, "relative" means:**
- 18 (1) a husband;
- 19 (2) a wife;
- 20 (3) a father, grandfather, or stepfather;
- 21 (4) a mother, grandmother, or stepmother;
- 22 (5) a son, grandson, stepson, or son-in-law;
- 23 (6) a daughter, granddaughter, stepdaughter, or
- 24 daughter-in-law;

- 1           **(7) a brother or stepbrother;**
- 2           **(8) a sister or stepsister;**
- 3           **(9) an aunt;**
- 4           **(10) an uncle;**
- 5           **(11) a niece;**
- 6           **(12) a nephew; or**
- 7           **(13) a first cousin.**
- 8           **(b) For purposes of this chapter, a relative by adoption,**
- 9           **half-blood, marriage, or remarriage shall be treated as a relative**
- 10           **of whole kinship.**
- 11           **Sec. 3. An individual who is a relative of a township officer or**
- 12           **employee may not be employed by the township in a position in**
- 13           **which the individual would have a direct supervisory or**
- 14           **subordinate relationship with the officer or employee who is the**
- 15           **individual's relative.**
- 16           **Sec. 4. A township employee who marries another township**
- 17           **employee or officer may not continue to be employed in the same**
- 18           **position the employee held before the marriage if the employee**
- 19           **would have a direct supervisory or subordinate relationship with**
- 20           **the employee's spouse.**
- 21           **Sec. 5. This chapter does not require the termination or**
- 22           **reassignment before January 1, 2012, of any employee of a**
- 23           **township from any position held by that individual before July 1,**
- 24           **2010. This section expires January 1, 2012."**
- 25           Renumber all SECTIONS consecutively.
