MR. SPEAKER:

I move that House Bill 1324 be amended to read as follows:

- 1           Page 2, line 11, after "(a)" insert "**For purposes of this section, in**
- 2           **a county containing a consolidated city "county executive" refers**
- 3           **to the board of commissioners of the county as provided in**
- 4           **IC 36-3-3-10.**
- 5           **(b)".**
- 6           Page 2, delete lines 12 through 24, begin a new line blocked left and
- 7           insert:
- 8           **""vacant parcel" refers to a parcel that satisfies all the following:**
- 9           **(1) A lien has been acquired on the parcel under section 6(a)**
- 10           **of this chapter.**
- 11           **(2) The parcel is unimproved on the date the parcel is offered**
- 12           **for sale under this chapter.**
- 13           **(3) The construction of a structure intended for residential use**
- 14           **on the parcel is permitted by law.**
- 15           **(4) On the date the parcel is offered for sale under this**
- 16           **chapter, the parcel is contiguous to one (1) or more parcels**
- 17           **that satisfy the following:**
- 18           **(A) One (1) or more of the following are located on the**
- 19           **contiguous parcel:**
- 20           **(i) A structure occupied for residential use.**
- 21           **(ii) A structure used in conjunction with a structure**
- 22           **occupied for residential use.**
- 23           **(B) The contiguous parcel is eligible for the standard**
- 24           **deduction under IC 6-1.1-12-37."**
