HOUSE BILL No. 1078

DIGEST OF HB 1078 (Updated January 19, 2010 2:18 pm - DI 103)

Citations Affected: IC 9-21; IC 9-24; IC 14-16.

Synopsis: Vehicle matters. Revises provisions governing the use of golf carts on certain county roads. Provides that an ordinance authorizing the use of golf carts on county roads must require that: (1) an individual who operates a golf cart on a county road hold a driver's license; and (2) a fine assessed for a violation of the ordinance be deposited in the general fund of the county. Specifies that the violation of an ordinance governing the use of a golf cart on a state highway in the county is considered an ordinance violation (instead of a Class C infraction). Requires a collector snowmobile to be registered with the department of natural resources in order to be operated on public property.

Effective: July 1, 2010.

HOUSE BILL No. 1078

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-21-1-3.3, AS AMENDED BY P.L.182-2009(ss),
2 SECTION 292, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2010]: Sec. 3.3. (a) A **county**, city, or ~~a~~ town
4 may adopt by ordinance traffic regulations concerning the use of golf
5 carts on a highway under the jurisdiction of the **county**, city, or ~~the~~
6 town. An ordinance adopted under this subsection may not:
7 (1) conflict with or duplicate another state law; or
8 (2) conflict with a driver's licensing requirement of another
9 provision of the Indiana Code.
10 (b) A fine assessed for a violation of a traffic ordinance adopted by

2 SECTION 2. IC 9-21-9-0.5, AS AMENDED BY P.L.150-2009,
3 SECTION 14, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2010]: Sec. 0.5. (a) This chapter does not apply to the
5 following:

6 (1) An electric personal assistive mobility device.

7 (2) A low speed vehicle.

8 (3) Except as provided in subsection (b), a golf cart.

23 (B) road construction or maintenance machinery, except where
24 the road roller or machinery is required to be registered under

 14 (6) A nonresident whose home state or country does not require

 17 state or country as an operator if the nonresident is at least sixteen
 18 (16) years and thirty (30) days of age and less than eighteen (18)
 19 years of age or as a chauffeur if the nonresident is at least
 20 eighteen (18) years of age, for not more than sixty (60) days in
 21 any one (1) year if the following conditions exist:
 22 (A) The unlicensed nonresident is the owner of the motor
 23 vehicle or the authorized driver of the vehicle.
 24 (B) The vehicle has been registered for the current year in the
 25 state or country of which the owner is a resident.
 26 (C) The motor vehicle at all times displays a registration plate
 27 issued in the home state or country of the owner.
 28 (D) The nonresident owner or driver has in the owner's or
 29 driver's immediate possession a registration card evidencing
 30 ownership and registration in the owner's or driver's home
 31 state or country or is able at any required time or place to do
 32 the following:
 33 (i) Prove lawful possession or the right to operate the motor
 34 vehicle.
 35 (ii) Establish the nonresident's proper identity.
 36 (7) An individual who is legally licensed to operate a motor
 37 vehicle in the state of the individual's residence and who is
 38 employed in Indiana, subject to the restrictions imposed by the
 39 state of the individual's residence.
 40 (8) A new resident of Indiana who possesses an unexpired driver's
 41 license issued by the resident's former state of residence, for a
 42 period of sixty (60) days after becoming a resident of Indiana.

1 (9) An individual who is an engineer, a conductor, a brakeman, or
2 another member of the crew of a locomotive or a train that is

 HOUSE MOTION

Mr. Speaker: I move that House Bill 1078 be amended to read as follows:

Page 4, after line 10, begin a new paragraph and insert:

"SECTION 4. IC 14-16-1-1.8 IS ADDED TO THE INDIANA CODE AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2010]: **Sec. 1.8. As used in this chapter, "collector snowmobile" means a snowmobile that is:**

- (1) **at least twenty-five (25) years old; and**
- (2) **owned and operated as a collector snowmobile for participation in special events of limited duration, including races, parades, and other group events.**

SECTION 5. IC 14-16-1-8, AS AMENDED BY P.L.225-2005, SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2010]: Sec. 8. (a) Except as otherwise provided, the following may not be operated on public property unless registered:

- (1) An off-road vehicle.
- (2) A snowmobile **(including a collector snowmobile).**

(b) Except as provided under subsection (c), ~~a vehicle that is purchased after December 31, 2003;~~ **the following** must be registered under this chapter:

- (1) **A vehicle that is purchased after December 31, 2003.**
- (2) **A collector snowmobile.**

(c) Registration is not required for the following vehicles:

- (1) ~~A~~ **An off-road** vehicle that is exclusively operated in a special event of limited duration that is conducted according to a prearranged schedule under a permit from the governmental unit having jurisdiction.
- (2) A vehicle being operated by a nonresident of Indiana as authorized under section 19 of this chapter.

(3) A vehicle being operated for purposes of testing or demonstration with temporary placement of numbers as set forth in section 16 of this chapter.

(4) A vehicle the operator of which has in the operator's possession a bill of sale from a dealer or private individual that includes the following:

(A) The purchaser's name and address.

(B) A date of purchase that is not more than thirty-one (31) days preceding the date that the operator is required to show the bill of sale.

(C) The make, model, and vehicle number of the vehicle provided by the manufacturer as required by section 13 of this chapter."

Renumber all SECTIONS consecutively.
