DIGEST OF HB 1178 (Updated January 14, 2010 9:34 am - DI 116)

**Citations Affected:** IC 10-16.

**Synopsis:** Returning National Guard. Requires the adjutant general of the Indiana National Guard to require a member of the Indiana National Guard who completes a United States Department of Defense form "Post-Deployment Health Reassessment" (PDHRA) to participate in a face-to-face clinical interview with a trained health care provider concerning the Indiana National Guard member's PDHRA. (Currently, the Department of Defense provides that a PDHRA clinical interview may be conducted in person or over the telephone.)

**Effective:** July 1, 2010.

## HOUSE BILL No. 1178



A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 10-16-7-24 IS ADDED TO THE INDIANA CODE  
 2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
 3 1, 2010]: **Sec. 24. (a) As used in this section, "PDHRA" refers to the**  
 4 **United States Department of Defense form "Post-Deployment**  
 5 **Health Reassessment" (DD Form 2900) or a successor form**  
 6 **adopted by the United States Department of Defense.**  
 7 **(b) As used in this section, "trained health care provider" has**  
 8 **the meaning set forth in the United States Department of Defense**  
 9 **Instruction 6490.03 or a successor instruction adopted by the**  
 10 **United States Department of Defense.**  
 11 **(c) The adjutant general shall require a member of the Indiana**  
 12 **National Guard who completes a PDHRA to participate in a**  
 13 **face-to-face clinical interview with a trained health care provider**  
 14 **concerning the Indiana National Guard member's PDHRA.**  
 15 **(d) The adjutant general may contract with a trained health**  
 16 **care provider to provide the clinical interview described in**  
 17 **subsection (c).**
