MR. SPEAKER:

Your Committee on Public Health, to which was referred House Bill 1132, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:

- 1 Page 2, line 9, delete "Interest" and insert "**Beginning July 1, 2011,**
- 2 **interest**".
- 3 Page 2, line 12, delete "Interest" and insert "**Subject to subsection**
- 4 **(d)(5), interest**".
- 5 Page 2, after line 21, begin a new paragraph and insert:
- 6 "SECTION 2. [EFFECTIVE UPON PASSAGE] **(a) The definitions**
- 7 **in IC 12-15-44.2 apply to this SECTION.**
- 8 **(b) As used in this SECTION, "task force" refers to the Indiana**
- 9 **check-up plan task force established by subsection (c).**
- 10 **(c) The Indiana check-up plan task force is established to:**
- 11 **(1) study, monitor, and provide guidance and make**
- 12 **recommendations to the state concerning the Indiana**
- 13 **check-up plan;**
- 14 **(2) develop methods to increase availability of affordable**
- 15 **coverage for health care services for all Indiana residents;**

1 **(3) develop an education and orientation program for**
2 **individuals participating in the plan;**

3 **(4) monitor the impact of new federal health and health**
4 **insurance laws on the Indiana check-up plan; and**

5 **(5) make recommendations to the legislative council.**

6 **(d) The affirmative votes of a majority of the voting members**
7 **appointed to the task force are required for the task force to take**
8 **action on any measure, including final reports.**

9 **(e) The office of Medicaid policy and planning established by**
10 **IC 12-8-6-1 shall staff the task force.**

11 **(f) The task force consists of the members appointed to the**
12 **Indiana check-up plan task force established by P.L.218-2007,**
13 **SECTION 57, and serving on December 31, 2009. If there is a**
14 **vacancy on the task force, the appointing authority who appointed**
15 **the member whose position is vacant shall appoint another**
16 **member so that the task force consists of the following voting**
17 **members:**

18 **(1) Four (4) members described in subsection (g)(1) through**
19 **(g)(4) appointed by the speaker of the house of**
20 **representatives, two (2) of whom are appointed based on the**
21 **recommendation of the minority leader of the house of**
22 **representatives and none of whom are legislators.**

23 **(2) Four (4) members described in subsection (g)(5) through**
24 **(g)(8) appointed by the president pro tempore of the senate,**
25 **two (2) of whom are appointed based on the recommendation**
26 **of the minority leader of the senate and none of whom are**
27 **legislators.**

28 **(3) Four (4) members described in subsection (g)(9) through**
29 **(g)(12) appointed by the governor, not more than two (2) of**
30 **whom are members of the same political party.**

31 **(g) The members appointed under subsection (f) must represent**
32 **the following interests:**

33 **(1) Hospitals.**

34 **(2) Insurance companies.**

35 **(3) Primary care providers.**

36 **(4) Health professionals who are not primary care providers.**

37 **(5) Minority health concern experts.**

38 **(6) Business.**

- 1 **(7) Organized labor.**
- 2 **(8) Consumers.**
- 3 **(9) Children's health issues.**
- 4 **(10) Adult health issues.**
- 5 **(11) Mental health issues.**
- 6 **(12) Pharmaceutical industry.**
- 7 **(h) The secretary of the office of the secretary of family and**
- 8 **social services shall call the first meeting of the task force, at which**
- 9 **the members shall elect the chairperson of the task force.**
- 10 **(i) The task force shall report findings and make**
- 11 **recommendations to the governor and to the legislative council in**
- 12 **an electronic format under IC 5-14-6 as follows:**
- 13 **(1) A report not later than November 1, 2010.**
- 14 **(2) A final report not later than November 1, 2011.**
- 15 **(j) The task force members are not eligible for per diem**
- 16 **reimbursement or reimbursement for expenses incurred for travel**
- 17 **to and from task force meetings.**
- 18 **(k) This SECTION expires December 31, 2011.**
- 19 **SECTION 3. An emergency is declared for this act."**
- 20 Renumber all SECTIONS consecutively.
 (Reference is to HB 1132 as introduced.)
