Your Committee on Financial Institutions, to which was referred House Bill 1048, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:

- 37 Page 3, line 14, delete "residence;" and insert "**dwelling (as defined**
 38 **in IC 6-1.1-12-37) that the purchaser will occupy as a residence;**".

1 Page 3, line 17, delete "real estate agent" and insert "**broker or**
2 **salesperson**".

3 Page 3, line 18, delete "2." and insert "**3.**".

4 Page 3, between lines 19 and 20, begin a new paragraph and insert:

5 "**Sec. 4. A contract that:**

6 **(1) is for a term of at least three (3) years; and**

7 **(2) is executed after June 30, 2010;**

8 **is valid only if the contract is recorded in the recorder's office of**
9 **the county in which the dwelling that is the subject of the contract**
10 **is located.**".

11 Page 3, between lines 24 and 25, begin a new paragraph and insert:

12 "SECTION 4. IC 34-30-2-16.9 IS ADDED TO THE INDIANA
13 CODE AS A NEW SECTION TO READ AS FOLLOWS
14 [EFFECTIVE UPON PASSAGE]: **Sec. 16.9. IC 6-1.1-12-43.5**
15 **(Concerning a notary public's failure to provide a form concerning**
16 **property tax benefits and a notary public's liability with respect to**
17 **the content of the form).**".

18 Renumber all SECTIONS consecutively.
