

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 177 be amended to read as follows:

- 1 Page 3, line 7, delete "[EFFECTIVE JULY 1, 2010]:" and insert
2 "[EFFECTIVE JULY 1, 2011]:".
- 3 Page 3, line 37, delete "[EFFECTIVE JULY 1, 2010]:" and insert
4 "[EFFECTIVE JULY 1, 2011]:".
- 5 Page 4, line 41, delete "[EFFECTIVE JULY 1, 2010]:" and insert
6 "[EFFECTIVE JULY 1, 2011]:".
- 7 Page 5, line 28, delete "[EFFECTIVE JULY 1, 2010]:" and insert
8 "[EFFECTIVE JULY 1, 2011]:".
- 9 Page 5, line 42, delete "[EFFECTIVE JULY 1, 2010]:" and insert
10 "[EFFECTIVE JULY 1, 2011]:".
- 11 Page 6, line 12, delete "2010," and insert "**2011**,".
- 12 Page 6, line 16, delete "2011." and insert "**2012**,".
- 13 Page 6, after line 16, begin a new paragraph and insert:
14 "**SECTION 7. [EFFECTIVE UPON PASSAGE] (a) An interim**
15 **study committee is established to study all aspects of the**
16 **Indianapolis historic preservation commission and the historic**
17 **preservation commissions of other counties, cities, and towns in**
18 **Indiana.**
- 19 **(b) The legislative council shall appoint the following twelve (12)**
20 **members:**
- 21 **(1) Three (3) members of the senate who reside in Marion**
22 **County.**
- 23 **(2) Three (3) members of the house of representatives who**
24 **reside in Marion County.**
- 25 **(3) Three (3) members of the senate who reside in a county**
26 **(other than Marion County), a city, or a town that has**
27 **established an historic preservation commission.**
- 28 **(4) Three (3) members of the house of representatives who**
29 **reside in a county (other than Marion County), a city, or a**
30 **town that has established an historic preservation**
31 **commission.**

- 1 **(c) The interim study committee shall issue a final report in an**
2 **electronic format under IC 5-14-6 before November 1, 2010, to the**
3 **legislative council containing the findings and recommendations of**
4 **the committee.**
- 5 **(d) The committee shall operate under the policies governing**
6 **study committees adopted by the legislative council.**
- 7 **(e) The affirmative votes of a majority of the voting members**
8 **appointed to the committee are required for the committee to take**
9 **action on any measure, including final reports.**
- 10 **(f) This SECTION expires November 1, 2010.**
11 **SECTION 8. An emergency is declared for this act."**
12 Renumber all SECTIONS consecutively.
