

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 407 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 9-13-2-69.8 IS ADDED TO THE INDIANA
- 4 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JANUARY 1, 2010 (RETROACTIVE)]: **Sec. 69.8.**
- 6 **"Gold Star family member" for purposes of IC 9-18-54, has the**
- 7 **meaning set forth in IC 9-18-54-1."**
- 8 Page 3, line 24, delete "or".
- 9 Page 3, line 27, before "Earlham" insert "(".
- 10 Page 3, line 27, after "Trust" insert ")".
- 11 Page 3, line 27, after "plates;" insert "**or**
- 12 **(II) IC 9-18-54 (Indiana Gold Star family member license**
- 13 **plates);"**.
- 14 Page 3, between lines 37 and 38, begin a new paragraph and insert:
- 15 "SECTION 6. IC 9-18-25-1, AS AMENDED BY P.L.30-2008,
- 16 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 17 JANUARY 1, 2010 (RETROACTIVE)]: Sec. 1. This chapter does not
- 18 apply to the following:
- 19 (1) Antique motor vehicle license plates (IC 9-18-12).
- 20 (2) Recovery vehicle license plates (IC 9-18-13).
- 21 (3) Personalized license plates (IC 9-18-15).
- 22 (4) Prisoner of war license plates (IC 9-18-17).
- 23 (5) Disabled veteran license plates (IC 9-18-18).
- 24 (6) Purple Heart license plates (IC 9-18-19).
- 25 (7) Indiana National Guard license plates (IC 9-18-20).
- 26 (8) Person with a disability license plates (IC 9-18-22).
- 27 (9) Amateur radio operator license plates (IC 9-18-23).
- 28 (10) In God We Trust license plates (IC 9-18-24.5).
- 29 (11) Pearl Harbor survivor license plates (IC 9-18-45.8).
- 30 (12) Hoosier veteran license plates (IC 9-18-50).
- 31 (13) Support our troops license plates (IC 9-18-51).

- 1 (14) Abraham Lincoln bicentennial license plates (IC 9-18-52).
 2 (15) **Indiana Gold Star family member license plates**
 3 **(IC 9-18-54).**

4 SECTION 7. IC 9-18-54 IS ADDED TO THE INDIANA CODE AS
 5 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 6 JANUARY 1, 2010 (RETROACTIVE)]:

7 **Chapter 54. Indiana Gold Star Family Member License Plate**
 8 **Sec. 1. As used in this chapter, "Gold Star family member"**
 9 **means:**

- 10 (1) a biological parent;
 11 (2) an adoptive parent;
 12 (3) a stepparent;
 13 (4) a biological child;
 14 (5) an adopted child;
 15 (6) a stepchild;
 16 (7) a sibling by blood;
 17 (8) a sibling by half blood;
 18 (9) a sibling by adoption;
 19 (10) a stepsibling; or
 20 (11) the spouse;

21 of an individual who has died while serving on active duty, or dies
 22 as a result of injuries sustained while serving on active duty, as a
 23 member of the armed forces of the United States or the national
 24 guard (as defined in IC 10-16-1-13).

25 **Sec. 2. The bureau shall design and issue an Indiana Gold Star**
 26 **family member license plate beginning January 1, 2010.**

27 **Sec. 3. An Indiana Gold Star family member license plate must**
 28 **include the following:**

- 29 (1) A basic design for the plate, with consecutive numbers or
 30 letters, or both, to properly identify the vehicle.
 31 (2) A background design, an emblem, or colors that designate
 32 the license plate as an Indiana Gold Star family member
 33 license plate.
 34 (3) Any other information that the bureau considers
 35 necessary.

36 **Sec. 4. An Indiana Gold Star family member license plate issued**
 37 **under this chapter may be displayed on the following:**

- 38 (1) A passenger motor vehicle.
 39 (2) A truck registered as a truck with a declared gross weight
 40 of not more than eleven thousand (11,000) pounds.
 41 (3) A recreational vehicle.

42 **Sec. 5. A person who is an Indiana Gold Star family member**
 43 **and who is eligible to register and display a license plate on a**
 44 **vehicle under this title may receive an Indiana Gold Star family**
 45 **member license plate for one (1) or more vehicles after doing the**
 46 **following:**

- 47 (1) Completing an application for an Indiana Gold Star family
 48 member license plate.

- 1 **(2) Providing the bureau with appropriate documentation as**
- 2 **defined by the bureau to establish eligibility as an Indiana**
- 3 **Gold Star family member.**
- 4 **(3) Paying the fee under section 6 of this chapter.**
- 5 **Sec. 6. The fee for an Indiana Gold Star family member license**
- 6 **plate is the appropriate fee under IC 9-29-5-38.6."**
- 7 Page 7, between lines 39 and 40, begin a new paragraph and insert:
- 8 "SECTION 14. IC 9-29-5-38.6 IS ADDED TO THE INDIANA
- 9 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 10 [EFFECTIVE JANUARY 1, 2010 (RETROACTIVE)]: **Sec. 38.6. A**
- 11 **vehicle registered under IC 9-18-54 is subject to an annual**
- 12 **registration fee and any other fee or tax required of a person**
- 13 **registering a vehicle under this title."**
- 14 Renumber all SECTIONS consecutively.
