

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 407 be amended to read as follows:

- 1 Delete the title and insert the following:  
2 A BILL FOR AN ACT to amend the Indiana Code concerning  
3 motor vehicles and to make an appropriation.  
4 Page 3, line 24, delete "or".  
5 Page 3, line 25, reset in roman "(HH) IC 9-18-52 (Abraham Lincoln  
6 bicentennial license".  
7 Page 3, line 26, reset in roman "plates); or".  
8 Page 3, line 27, reset in roman "(II)".  
9 Page 3, line 27, delete "(HH)".  
10 Page 3, between lines 37 and 38, begin a new paragraph and insert:  
11 "SECTION 5. IC 9-18-52-2, AS ADDED BY P.L.30-2008,  
12 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
13 UPON PASSAGE]: Sec. 2. An Abraham Lincoln bicentennial license  
14 plate shall be available for issuance through December 31, ~~2009~~ **2013**.  
15 SECTION 6. IC 9-18-52-3, AS ADDED BY P.L.30-2008,  
16 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
17 UPON PASSAGE]: Sec. 3. The renewal of the registration of an  
18 Abraham Lincoln bicentennial license plate must be available through  
19 the renewal cycle in ~~2012~~, **2016**, subject to ~~IC 9-18-2-8(g)~~.  
20 **IC 9-18-2-8(a)**. Notwithstanding section 8 of this chapter, a vehicle  
21 may display an Abraham Lincoln bicentennial license plate in ~~2013~~,  
22 **2017**, subject to ~~IC 9-18-2-8(g)~~. **IC 9-18-2-8(a)**.  
23 SECTION 7. IC 9-18-52-6, AS ADDED BY P.L.30-2008,  
24 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
25 UPON PASSAGE]: Sec. 6. A person who is a resident of Indiana and  
26 who is eligible to register and display a license plate on a vehicle under  
27 this title may apply for and receive an Abraham Lincoln bicentennial  
28 license plate for one (1) or more vehicles after doing the following:  
29 (1) Completing an application for an Abraham Lincoln  
30 bicentennial license plate.  
31 (2) Paying the ~~fee~~ **fees** under section 7 of this chapter.

1 SECTION 8. IC 9-18-52-7, AS ADDED BY P.L.30-2008,  
 2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 3 UPON PASSAGE]: Sec. 7. **(a) The ~~fee fees~~ for an Abraham Lincoln  
 4 bicentennial license plate is the appropriate fee under ~~IC 9-29-5-34.5~~.**  
 5 **are as follows:**

6 **(1) The appropriate fee under IC 9-29-5-34.7.**

7 **(2) An annual fee of twenty-five dollars (\$25).**

8 **(b) The annual fee described in subsection (a)(2) shall be  
 9 collected by the bureau.**

10 **(c) The annual fee described in subsection (a)(2) shall be  
 11 deposited in the Indiana State Museum Foundation trust fund  
 12 established by section 7.5 of this chapter.**

13 SECTION 9. IC 9-18-52-7.5 IS ADDED TO THE INDIANA CODE  
 14 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE  
 15 UPON PASSAGE]: Sec. 7.5. **(a) The Indiana State Museum  
 16 Foundation trust fund is established.**

17 **(b) The treasurer of state shall invest the money in the Indiana  
 18 State Museum Foundation trust fund not currently needed to meet  
 19 the obligations of the Indiana State Museum Foundation trust fund  
 20 in the same manner as other public funds are invested. Interest  
 21 that accrues from these investments shall be deposited in the  
 22 Indiana State Museum Foundation trust fund. Money in the  
 23 Indiana State Museum Foundation trust fund is continuously  
 24 appropriated for the purposes of this section.**

25 **(c) The commissioner shall administer the Indiana State  
 26 Museum Foundation trust fund. Expenses of administering the  
 27 Indiana State Museum Foundation trust fund shall be paid from  
 28 money in the fund.**

29 **(d) On June 30 of each year, the commissioner shall distribute  
 30 the money from the Indiana State Museum Foundation trust fund  
 31 to the Indiana State Museum Foundation, Inc. for use concerning  
 32 the Lincoln collection.**

33 **(e) Money in the Indiana State Museum Foundation trust fund  
 34 at the end of a state fiscal year does not revert to the state general  
 35 fund.**

36 SECTION 10. IC 9-18-52-8, AS ADDED BY P.L.30-2008,  
 37 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 38 UPON PASSAGE]: Sec. 8. This chapter expires December 31, ~~2013~~.  
 39 **2017."**

40 Page 7, between lines 39 and 40, begin a new paragraph and insert:

41 "SECTION 17. IC 9-29-5-34.5, AS AMENDED BY P.L.30-2008,  
 42 SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 43 UPON PASSAGE]: Sec. 34.5. A vehicle registered under

44 ~~(1) IC 9-18-24.5 or~~

45 ~~(2) IC 9-18-52;~~

46 is subject to an annual registration fee and any other fee or tax required  
 47 of a person registering a vehicle under this title.

1 SECTION 18. IC 9-29-5-34.7 IS ADDED TO THE INDIANA  
2 CODE AS A NEW SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE UPON PASSAGE]: **Sec. 34.7. In addition to the fee**  
4 **described in IC 9-18-52-7(a)(2), a vehicle registered under**  
5 **IC 9-18-52 is subject to an annual registration fee for a vehicle of**  
6 **the same classification under this chapter and any other fee or tax**  
7 **required of a person registering a vehicle under this title."**

8 Renumber all SECTIONS consecutively.
