

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1320 be amended to read as follows:

- 1 Page 9, delete line 5 and insert "**state police department enters**
- 2 **into a contract**".
- 3 Page 9, line 9, delete "JULY 1, 2011]" and insert "UPON
- 4 PASSAGE]".
- 5 Page 9, line 9, delete "The attorney general" and insert "**Before July**
- 6 **1, 2010, the state police department may enter into a contract with**
- 7 **a vendor to implement a real time PSE tracking system (as defined**
- 8 **by section 14.8(b) of this chapter) that includes the following**
- 9 **capabilities:**
- 10 **(1) Monitor the sale of nonprescriptive products that contain**
- 11 **ephedrine or pseudoephedrine.**
- 12 **(2) Track sales, inquiries to purchase, and denials to purchase**
- 13 **ephedrine or pseudoephedrine.**
- 14 **(3) Contain a real time stop sale function:**
- 15 **(A) that accesses sales records of all state retail locations**
- 16 **and retail locations in states bordering Indiana that use**
- 17 **similar tracking systems; and**
- 18 **(B) enforces state and federal quantity limits.**
- 19 **(b) The state police department may enter into a contract with**
- 20 **a vendor that provides a similar PSE tracking system in a state**
- 21 **bordering Indiana. The contract must establish the roles and**
- 22 **responsibilities of the state police department and the vendor."**
- 23 Page 9, line 14, delete "(b) The memorandum of understanding" and
- 24 insert "**(c) The contract**".
- 25 Page 9, line 22, after "system" insert "**as authorized by the state**
- 26 **police department**".
- 27 Page 9, line 28, delete "entity" and insert "**vendor**".
- 28 Page 9, line 30, delete "entity" and insert "**vendor**".
- 29 Page 9, line 31, after "enforcement" insert", **except that the vendor**
- 30 **may analyze sales data to access and improve efficiency of the**

- 1 **system".**
- 2 Page 9, line 33, delete "entity" and insert "**vendor**".
- 3 Page 9, line 34, after "state" insert "**and with Indiana's bordering**
- 4 **states that use a similar system**".
- 5 Page 10, after line 7, begin a new paragraph and insert:
- 6 "SECTION 7. [EFFECTIVE JULY 1, 2010] **(a) During the 2011**
- 7 **legislative interim the health finance commission shall study the**
- 8 **implementation and effectiveness of the PSE tracking system (as**
- 9 **defined by IC 35-48-4-14.8(b), as added by this act).**
- 10 **(b) This SECTION expires January 1, 2012.**
- 11 SECTION 8. **An emergency is declared for this act.**"
- 12 Renumber all SECTIONS consecutively.
