

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Corrections, Criminal, and Civil Matters, to which was referred Senate Bill No. 265, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 3, line 14, delete "and".
- 2 Page 3, line 14, after "(4)," insert "**and (5)**".
- 3 Page 4, line 16, delete "IC 35-44-3-3(b)," and insert
- 4 "**IC 35-44-3-3(b) and the person exceeded the speed limit by at least**
- 5 "**twenty (20) miles per hour while committing the felony,**".
- 6 Page 4, between lines 24 and 25, begin a new line block indented
- 7 and insert:
- 8 "**(5) If the person is convicted of a felony involving the use of**
- 9 "**a motor vehicle under IC 35-44-3-3(b), the person exceeded**
- 10 "**the speed limit by at least twenty (20) miles per hour while**
- 11 "**committing the felony, and the person has a prior unrelated**
- 12 "**conviction for a felony under IC 35-44-3-3(b), for two (2)**
- 13 "**years after the date the person:**
- 14 "**(A) was convicted, if the person was not sentenced to a**
- 15 "**term of incarceration; or**
- 16 "**(B) was released from incarceration, if the person was**
- 17 "**sentenced to a term of incarceration.**
- 18 "**The convicted person has the burden of applying for a new or**
- 19 "**renewal license and establishing that the two (2) year period**
- 20 "**described in this subdivision has elapsed.**".
- 21 Page 5, delete lines 7 through 42.

- 1 Delete pages 6 through 8.
- 2 Page 9, delete lines 1 through 12.
- 3 Page 10, line 18, delete "(b)(1)(A), (b)(2), or (b)(3)," and insert "
4 (1) (b)(1)(A), if the person exceeded the speed limit by at least
5 twenty (20) miles per hour while committing the offense;
6 (2) (b)(2); or
7 (3) (b)(3);".
- 8 Page 10, line 18, beginning with "the" begin a new line blocked left.
- 9 Page 10, line 19, delete "shall" and insert "**may**".
- 10 Page 10, line 23, delete "IC 9-30-4-6(d)(4)." and insert
11 "**IC 9-30-4-6(d)(4) or IC 9-30-4-6(d)(5)**".
- 12 Renumber all SECTIONS consecutively.
(Reference is to SB 265 as introduced.)
