DIGEST OF SB 497 (Updated April 12, 2011 3:00 pm - DI 109)

Citations Affected: IC 21-12; IC 21-43; noncode.

Synopsis: Higher education scholarship. Provides an early graduation scholarship to a student who graduates from high school before grade 12. Requires the state board of education to amend its rules to facilitate graduation from high school in less than seven semesters. Allows a student to participate in an early college, a dual credit, a double up for college, or a dual enrollment program during any grade in high school. Requires the department of education to report early graduation scholarship student information to the state student assistance

commission (SSACI). Requires the department of education to transfer tuition support to SSACI for early graduation scholarship students that are accepted at a higher education institution. Provides for the payment of the scholarship by SSACI to the higher education institution from these transfers. Specifies that the early graduation scholarship amount is equal to the foundation amount minus a proportionate amount of any reduction in the total amount of basic tuition support distributed to publically supported schools, as determined on a per eligible pupil basis, in the calendar year in which an early graduation scholarship is awarded. Permits a higher education scholarship to be used for fees, books, supplies, and equipment required for courses of instruction. Provides that the unused balance of a scholarship shall be applied to educational costs incurred in a subsequent school year. Provides for the recovery of an unused scholarship.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- (1) First, to any outstanding tuition and fees.
- (2) Second, for fees, books, supplies, and equipment required for courses of instruction.

The balance of the scholarship not used in a school year does not revert to the student but shall be applied by the institution to the costs described in subdivisions (1) and (2) that are incurred by the scholarship recipient in the next school year. If a scholarship recipient transfers to another approved postsecondary educational institution before the entire amount of the scholarship is used, the institution shall transfer the unused balance to the other institution for use by the scholarship recipient for the payment of costs described in subdivisions (1) and (2). If a scholarship recipient ceases to be a student in good standing at an approved postsecondary educational institution with a campus located in Indiana and engaged in a program that will lead to an approved postsecondary degree or credential, the balance of any unused scholarship shall be returned to the commission in conformity with the procedures prescribed by the commission.

Sec. 7. The amount of an early graduation scholarship is the result of:

- (1) the STEP ONE amount specified in IC 20-43-5-4; minus
 - (2) a proportionate amount of any reduction in the total amount of basic tuition support (as defined in IC 20-43-1-8) distributed to publically supported schools, as determined on a per eligible pupil basis;
- in the calendar year in which an early graduation scholarship is awarded. The amount of any reduction under subdivision (2) shall be determined by the department of education.

Sec. 8. The amount of an early graduation scholarship awarded under this chapter shall not be considered as a financial resource in a determination of the amount of any grant or scholarship under this article or, except as required by federal law, the amount of any other grant or scholarship administered by the commission.

Sec. 9. An institution is not required to change its admission standards to accept an individual to whom the commission has issued an early graduation scholarship. The scholarship may not be used for remedial course work at the institution. The institution shall provide facilities and instruction to the applicant on the same terms as to other students.

Sec. 10. (a) The commission shall notify the department of the amount of early graduation scholarships granted for each state fiscal year. The department shall deduct the scholarship amount

"SECTION 1. IC 20-43-4-2, AS ADDED BY P.L.2-2006, SECTION 166, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 2. A school corporation's ADM is the number of eligible pupils enrolled in:

- (1) the school corporation; or
- (2) a transferee corporation;

An adjustment in a school corporation's ADM under this section does not increase the amount appropriated for state tuition support for a state fiscal year or the maximum state distribution for a calendar year.
