I move that Engrossed Senate Bill 1 be amended to read as follows:

- 1 Replace the effective dates in SECTIONS 28 through 33 with
- 2 "[EFFECTIVE JULY 1, 2013]".
- 3 Replace the effective date in SECTION 37 with "[EFFECTIVE
- 4 JULY 1, 2013]".
- 5 Page 1, between the enacting clause and line 1, begin a new
- 6 paragraph and insert:
- 7 "SECTION 1. IC 2-5-32.3 IS ADDED TO THE INDIANA CODE
- 8 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 9 JULY 1, 2011]:
- 10 **Chapter 32.3. Interim Study Committee on Teacher Evaluations**
- 11 **and Salaries**
- 12 **Sec. 1. As used in this chapter, "committee" refers to the**
- 13 **interim study committee on teacher evaluations and salaries**
- 14 **established under section 2 of this chapter.**
- 15 **Sec. 2. The interim study committee on teacher evaluations and**
- 16 **salaries is established.**
- 17 **Sec. 3. The committee shall study and make recommendations**
- 18 **to the legislative council concerning the following issues:**
- 19 **(1) Systems of teacher evaluation, including peer and**
- 20 **supervisor evaluations.**
- 21 **(2) Measures of teacher performance.**
- 22 **(3) Designations of teacher performance.**
- 23 **(4) Appeals procedures.**
- 24 **(5) Appropriate remediation measures.**

- 1 **(6) Salary schedules.**
- 2 **(7) Criteria for increments and raises, including the weight to**
- 3 **be given factors such as education and length of employment.**
- 4 **(8) The relationship between evaluations and raises.**
- 5 **Sec. 4. Before November 1, 2012, the committee shall issue a**
- 6 **final report to the legislative council containing the findings and**
- 7 **recommendations of the committee.**
- 8 **Sec. 5. This chapter expires December 31, 2012."**
- 9 Page 37, line 39, delete "IC 20-28-7;".
- 10 Page 37, line 39, delete "IC 20-28-9-4;" and insert "IC 20-28-9-4".
- 11 Page 37, delete lines 40 through 42.
- 12 Delete page 38.
- 13 Renumber all SECTIONS consecutively.
