I move that Engrossed Senate Bill 465 be amended to read as follows:

- 1           Page 56, between lines 30 and 31, begin a new paragraph and insert:
- 2           "SECTION 49. IC 31-34-1-17 IS ADDED TO THE INDIANA
- 3           CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 4           [EFFECTIVE JULY 1, 2011]: **Sec. 17. (a) If an alleged father is**
- 5           **involved in any proceeding described in this chapter, the court**
- 6           **shall order a genetic test to determine paternity not later than**
- 7           **ninety (90) days after the alleged father becomes involved in the**
- 8           **proceeding.**
- 9           **(b) If the genetic test results obtained under subsection (a)**
- 10          **indicate that the alleged father is excluded as the father of the**
- 11          **child, the alleged father may no longer be involved in the**
- 12          **proceeding."**
- 13          Page 58, between lines 23 and 24, begin a new paragraph and insert:
- 14          "SECTION 51. IC 31-34-8-3.5 IS ADDED TO THE INDIANA
- 15          CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 16          [EFFECTIVE JULY 1, 2011]: **Sec. 3.5. (a) If an alleged father is**
- 17          **ordered to participate in a program of informal adjustment under**
- 18          **this chapter, the court shall order a genetic test to determine**
- 19          **paternity not later than ninety (90) days after the alleged father**
- 20          **becomes involved in the proceeding.**
- 21          **(b) If the genetic test results obtained under subsection (a)**
- 22          **indicate that the alleged father is excluded as the father of the**
- 23          **child, the alleged father may no longer be involved in the**
- 24          **proceeding.**

1 SECTION 52. IC 31-34-16-5 IS ADDED TO THE INDIANA  
2 CODE AS A NEW SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2011]: **Sec. 5. (a) If an alleged father is the**  
4 **subject of an order under this chapter, the court shall order a**  
5 **genetic test to determine paternity not later than ninety (90) days**  
6 **after the entry of the order.**

7 **(b) If the genetic test results obtained under subsection (a)**  
8 **indicate that the alleged father is excluded as the father of the**  
9 **child, the court shall reverse the order.**

10 SECTION 53. IC 31-34-19-11 IS ADDED TO THE INDIANA  
11 CODE AS A NEW SECTION TO READ AS FOLLOWS  
12 [EFFECTIVE JULY 1, 2011]: **Sec. 11. (a) If an alleged father is:**

13 **(1) involved in any proceeding; or**

14 **(2) the subject of any order;**

15 **under this chapter, the court shall order a genetic test to determine**  
16 **paternity not later than ninety (90) days after the alleged father**  
17 **becomes involved in the proceeding or becomes subject to the**  
18 **order.**

19 **(b) If the genetic test results obtained under subsection (a)**  
20 **indicate that the alleged father is excluded as the father of the**  
21 **child, the alleged father may no longer be involved in the**  
22 **proceeding and the order shall be reversed."**

23 Page 60, between lines 22 and 23, begin a new paragraph and insert:

24 "SECTION 56. IC 31-34-20-7 IS ADDED TO THE INDIANA  
25 CODE AS A NEW SECTION TO READ AS FOLLOWS  
26 [EFFECTIVE JULY 1, 2011]: **Sec. 7. (a) If an alleged father is the**  
27 **subject of any order under this chapter, the court shall order a**  
28 **genetic test to determine paternity not later than ninety (90) days**  
29 **after entry of the order.**

30 **(b) If the genetic test results obtained under subsection (a)**  
31 **indicate that the alleged father is excluded as the father of the**  
32 **child, the court shall reverse the order."**

33 Page 63, between lines 7 and 8, begin a new paragraph and insert:

34 "SECTION 60. IC 31-35-2-9 IS ADDED TO THE INDIANA CODE  
35 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
36 1, 2011]: **Sec. 9. (a) If an alleged father is involved in any**  
37 **proceeding under this chapter, the court shall order a genetic test**  
38 **to determine paternity not later than ninety (90) days after the**  
39 **alleged father becomes involved in the proceeding.**

40 **(b) If the genetic test results obtained under subsection (a)**  
41 **indicate that the alleged father is excluded as the father of the**

1 **child, the alleged father may no longer be involved in the**  
2 **proceeding."**

3 Renumber all SECTIONS consecutively.
