MR. SPEAKER:

I move that Engrossed Senate Bill 473 be amended to read as follows:

- 1 Page 4, between lines 9 and 10, begin a new paragraph and insert:
- 2 "SECTION 4. IC 8-15.5-4-1.5, AS ADDED BY P.L.85-2010,
- 3 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2011]: Sec. 1.5. (a) The authority may not issue a request for
- 5 proposals for a toll road project under this article unless the authority
- 6 has received a preliminary feasibility study and an economic impact
- 7 study for the project from the department, prepared in the same manner
- 8 as required by IC 8-15.7-4-1.
- 9 (b) The economic impact study must, at a minimum, include an
- 10 analysis of the following matters with respect to the proposed project:
- 11 (1) Economic impacts on existing commercial and industrial
- 12 development.
- 13 (2) Potential impacts on employment.
- 14 (3) Potential for future development near the project area,
- 15 including consideration of locations for interchanges that will
- 16 maximize opportunities for development.
- 17 (4) Fiscal impacts on revenues to local units of government.
- 18 (5) Demands on government services, such as public safety,
- 19 public works, education, zoning and building, and local airports.
- 20 The authority shall post a copy of the economic impact study **and the**
- 21 **preliminary feasibility study** on the authority's Internet web site and
- 22 shall also provide copies of the study to the governor and the legislative
- 23 council (in an electronic format under IC 5-14-6). **The authority shall**
- 24 **notify the executive of each county described in subsection (c) that**

1 **the studies are posted on the authority's Internet web site.**
2 (c) After completion of the economic impact study, the authority
3 must conduct a public hearing on the results of the study in the county
4 seat of the county in which the proposed project would be located. At
5 least ten (10) days before each public hearing, the authority shall:
6 (1) post notice of the public hearing on the authority's Internet
7 web site;
8 (2) publish notice of the public hearing one (1) time in accordance
9 with IC 5-3-1 in two (2) newspapers of general circulation in the
10 county; and
11 (3) include in the notices under subdivisions (1) and (2):
12 (A) the date, time, and place of the hearing;
13 (B) the subject matter of the hearing;
14 (C) a description of the purpose of the economic impact study;
15 (D) a description of the proposed project and its location; and
16 (E) a statement concerning the availability of the study on the
17 authority's Internet web site.
18 At the hearing, the authority shall allow the public to be heard on **the**
19 **preliminary feasibility study**, the economic impact study, and the
20 proposed project."
21 Page 8, line 2, after "IC 5-14-6)." insert "**The department shall**
22 **provide notice to the executive of each county described in**
23 **subdivision (1) that the studies are posted on the department's**
24 **Internet web site.**".
25 Renumber all SECTIONS consecutively.
