3 JULY 1, 2011]: Sec. 7. **(a)** An operator or a person who has an interest
4 in an operator may not make a contribution to a candidate or a
5 committee during the following periods:

6 (1) The term during which the operator is a party to a
7 public-private agreement entered into under this article.

8 (2) The three (3) years following the final expiration or
9 termination of the public-private agreement described in
10 subdivision (1).

11 **(b) A contractor, an officer of a contractor, or a political action
12 committee of a contractor may not make a contribution to a
13 candidate or a committee:**

38 **(2) an individual or entity that has a contract with the
39 authority or an operator."**

40 Page 14, between lines 14 and 15, begin a new paragraph and insert

41 "SECTION 18. IC 8-15.7-16-7, AS ADDED BY P.L.47-2006,
42 SECTION 40, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
43 JULY 1, 2011]: Sec. 7. **(a)** An operator or a person who has an interest
44 in an operator may not make a contribution to a candidate or a
45 committee during the following periods:

46 (1) The term during which the operator is a party to a

1 public-private agreement entered into under this article.
2 (2) The three (3) years following the final expiration or
3 termination of the public-private agreement described in
4 subdivision (1).
5 **(b) A contractor, an officer of a contractor, or a political action**
6 **committee of a contractor may not make a contribution to a**
7 **candidate or a committee:**
8 **(1) while the contract is in effect; and**
9 **(2) during the three (3) years following the final expiration or**
10 **termination of the contract."**
