# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that Engrossed Senate Bill 528 be amended to read as follows:

- 1 Page 20, delete lines 22 through 42, begin a new paragraph and
- 2 insert:
- 3 "SECTION 36. IC 9-30-6-12 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE JANUARY 1, 2012]: Sec. 12. (a) If a court
- 5 recommends suspension of the driving privileges under this chapter,
- 6 IC 9-30-5, or IC 9-30-9:
- 7 (1) the bureau shall comply with the recommendation of
- 8 suspension, and the driving privileges of the person remain
- 9 suspended for the period set by the court; and
- 10 (2) the person shall surrender to the court all licenses, permits, or
- 11 receipts issued to the person, and the court shall immediately
- 12 forward the licenses, permits, or receipts to the bureau with the
- 13 abstract of conviction or judgment.
- 14 (b) **Except as provided in subsection (c),** during the three (3) years
- 15 following the termination of the suspension the person's driving
- 16 privileges remain suspended until the person provides proof of **future**
- 17 financial responsibility in force under IC 9-25.
- 18 (c) **If a court recommends suspension of a person's driving**
- 19 **privileges for a conviction under IC 9-30-5, during the three (3)**
- 20 **years following the termination of the suspension the person's**
- 21 **driving privileges remain suspended until the person provides**
- 22 **proof of future financial responsibility in force under IC 9-25.**
- 23 **However, if a court recommends suspension of the driving**
- 24 **privileges of a person who is arrested for or charged with an**

- 1 **offense committed under IC 9-30-5, the person is not required to**
- 2 **provide proof of financial responsibility under IC 9-25 unless the**
- 3 **person is convicted under IC 9-30-5.**
- 4 ~~(c)~~ **(d)** If at any time during the three (3) years following the
- 5 termination of the suspension imposed under subsection (a) a person
- 6 who has provided proof of **future** financial responsibility under
- 7 IC 9-25 fails to maintain the proof, the bureau shall suspend the
- 8 person's driving privileges until the person again provides proof of
- 9 **future** financial responsibility under IC 9-25.
- 10 ~~(d)~~ **(e)** An agency action under this section is not subject to
- 11 IC 4-21.5."
- 12 Page 21, delete lines 1 through 8.
- 13 Renumber all SECTIONS consecutively.
