MR. SPEAKER:

I move that Engrossed Senate Bill 575 be amended to read as follows:

- 1 Replace the effective dates in SECTIONS 1 through 34 with
- 2 "[EFFECTIVE JULY 1, 2011]".
- 3 Page 8, delete lines 20 through 22.
- 4 Page 8, line 23, delete "(c)" and insert "**(b)**".
- 5 Page 8, line 24, delete "the effective date of" and insert "**June 30,**
- 6 **2011.**".
- 7 Page 8, delete line 25.
- 8 Page 9, delete line 17.
- 9 Page 9, line 18, delete "(3)" and insert "**(2)**".
- 10 Page 9, line 19, delete "(4)" and insert "**(3)**".
- 11 Page 9, line 23, delete "(5)" and insert "**(4)**".
- 12 Page 9, line 28, delete "(6)" and insert "**(5)**".
- 13 Page 9, between lines 31 and 32, begin a new paragraph and insert:
- 14 "SECTION 17. IC 20-29-6-4.7 IS ADDED TO THE INDIANA
- 15 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 16 [EFFECTIVE UPON PASSAGE]: **Sec. 4.7. (a) A school employer**
- 17 **may not bargain collectively with the exclusive representative on**
- 18 **teacher evaluation procedures and criteria after this section has**
- 19 **been enacted into law.**
- 20 **(b) A contract entered into between a school employer and an**
- 21 **exclusive representative after this section has been enacted into law**
- 22 **may not extend past the end of a state budget biennium.**".
- 23 Page 17, line 13, delete "upon passage of this act." and insert "**July**
- 24 **1, 2011.**".

- 1 Page 17, line 14, after "shall" insert "**appoint the replacement**
- 2 **members of the Indiana Education Employment Relations Board**
- 3 **by July 1, 2011. Before appointing the members under this**
- 4 **SECTION, the governor shall**".
- 5 Page 17, line 17, delete "If" and insert "**However, if**".
- 6 Page 17, line 18, delete "within sixty" and insert "**before July 1,**
- 7 **2011,**".
- 8 Page 17, line 19, delete "(60) days after the governor's request,".
- 9 Page 17, line 23, delete "must".
- 10 Page 17, line 23, delete "not later than".
- 11 Renumber all SECTIONS consecutively.
