MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

- 1 Page 80, between lines 37 and 38, begin a new paragraph and insert:
- 2 **"Augmentation allowed, after review by the state budget**
- 3 **committee, for the sole purpose of providing state tuition support**
- 4 **for the number of eligible pupils enrolled in a charter school that**
- 5 **exceed the number of eligible pupils included in the adjusted ADM**
- 6 **of the charter school under IC 20-43-4-7, as amended by this act.**
- 7 **No part of the first \$6,247,700,000 appropriated for tuition support**
- 8 **may be used to provide state tuition support to a charter school for**
- 9 **these additional eligible pupils. The supplemental distribution**
- 10 **allowed by this paragraph shall be computed in the same manner**
- 11 **that state tuition support is calculated under IC 20-43, as amended**
- 12 **by this act. If state tuition support under IC 20-43, as amended by**
- 13 **this act, is proportionally reduced, the supplemental distribution**
- 14 **under this paragraph shall be proportionally reduced under the**
- 15 **same formula."**

- 17 apply".
- 18 Page 122, line 29, reset in roman "to a charter school."
- 19 Page 122, line 43, after "result." insert **"school corporation's**
- 20 **current ADM."**
- 21 Page 122, line 44, reset in roman "(b) A charter school's adjusted
- 22 ADM for purposes of this article is the".
- 23 Page 122, line 44, after "the" insert **"lesser of the"**.
- 24 Page 122, line 44, delete "charter school's current ADM." and insert

- 1 "charter school's:
- 2 (1) current ADM; or
- 3 (2) ADM for the year preceding the current year by one (1)
- 4 year."
- 5 Page 122, delete line 45, begin a new paragraph and insert:
- 6 "SECTION 71. IC 20-43-4-9 IS ADDED TO THE INDIANA CODE
- 7 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
- 8 JANUARY 1, 2012] **Sec. 9. A student count for a charter school that**
- 9 **affects the charter school's:**
- 10 (1) ADM; or
- 11 (2) **funding for a grant under IC 20-43-7 or IC 20-43-8;**
- 12 **in 2012 or 2013 is the lesser of the actual number of students or the**
- 13 **number of students included in the count for the charter school in**
- 14 **2011."**
- 15 Page 125, line 9, after "current" insert "**adjusted**".
- 16 Renumber all SECTIONS consecutively.
