I move that House Bill 1001 be amended to read as follows:

- 1 Page 117, between lines 16 and 17, begin a new paragraph and
- 2 insert:
- 3 "SECTION 60. IC 20-19-3-11 IS ADDED TO THE INDIANA
- 4 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 2011]: **Sec. 11. The department shall make**
- 6 **reduction of absenteeism in schools a policy priority and direct**
- 7 **school corporations and schools to:**
- 8 (1) **identify contributing factors of absenteeism; and**
- 9 (2) **develop chronic absence reduction plans.**
- 10 SECTION 61. IC 20-19-4-7, AS ADDED BY P.L.1-2005,
- 11 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 12 JULY 1, 2011]: Sec. 7. (a) The roundtable shall **study and** provide
- 13 recommendations on subjects related to education, **including early**
- 14 **childhood education**, to the following:
- 15 (1) The governor.
- 16 (2) The state superintendent.
- 17 (3) The general assembly.
- 18 (4) The state board.
- 19 (b) The recommendations to the general assembly must be in an
- 20 electronic format under IC 5-14-6.
- 21 SECTION 62. IC 20-20-28-4, AS ADDED BY P.L.1-2005,
- 22 SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 23 JULY 1, 2011]: Sec. 4. (a) The department shall establish pilot
- 24 programs targeting at risk students in the following areas:

- 1 (1) Early childhood parental information programs.
 2 (2) Latch key programs.
 3 (3) Preschool programs.
 4 (b) In establishing the pilot programs under this chapter, the
 5 department shall focus on implementing programs that:
 6 (1) **mirror proven early education programs; and**
 7 (2) enable the local school corporation and appropriate
 8 community agencies to cooperate with each other.
 9 (c) The department shall address the following in establishing the
 10 programs:
 11 (1) Screening for physical health problems that can inhibit school
 12 success.
 13 (2) Screening for learning disabilities.
 14 (3) Parental orientation and participation.
 15 (d) In addition, the department shall employ an early childhood
 16 specialist and support staff personnel to identify and determine ways
 17 to coordinate the educational programs offered by local youth serving
 18 organizations."
 19 Page 118, between lines 17 and 18, begin a new paragraph and
 20 insert:
 21 "SECTION 66. IC 20-26-5-33 IS ADDED TO THE INDIANA
 22 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
 23 [EFFECTIVE JULY 1, 2011]: **Sec. 33. School corporations shall**
 24 **share data on schools with a high number of chronic student**
 25 **absences with the department and with the office of the secretary**
 26 **of family and social services to:**
 27 (1) **target allocation of resources; and**
 28 (2) **identify or develop model programs to improve school**
 29 **attendance.**
 30 SECTION 67. IC 20-26-5-34 IS ADDED TO THE INDIANA
 31 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
 32 [EFFECTIVE JULY 1, 2011]: **Sec. 34. The governing body of a**
 33 **school corporation may contract with a private or public entity to**
 34 **provide professional development activities to help teachers and**
 35 **administrators understand the factors contributing to chronic**
 36 **absences from school and how to address those factors.**
 37 Page 120, between lines 29 and 30, begin a new paragraph and
 38 insert:
 39 "SECTION 69. IC 20-34-3-21 IS ADDED TO THE INDIANA
 40 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
 41 [EFFECTIVE JULY 1, 2011]: **Sec. 21. (a) The governing body of a**
 42 **school corporation may contract with a nonprofit organization to**
 43 **provide preventive and primary health care services in school**
 44 **based clinics to students enrolled in schools within the school**
 45 **corporation.**
 46 (b) **An individual employed by or volunteering at a school based**

1 **clinic described in subsection (a) may not provide any of the**
2 **following concerning abortion:**

3 **(1) Counseling.**

4 **(2) Literature.**

5 **(3) Advice or encouragement.**

6 **(4) Transportation or the arrangement of transportation.**

7 **(c) A school based clinic described in subsection (a) may not**
8 **distribute a contraceptive."**

9 Renumber all SECTIONS consecutively.
