# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

1           Page 139, between lines 18 and 19, begin a new paragraph and  
2           insert:  
3           "SECTION 96. [EFFECTIVE UPON PASSAGE] (a)  
4           **Notwithstanding any other law, including SECTION 21 of this act,**  
5           **no further review by the budget committee or approval or**  
6           **recommendation by the governor, the budget agency, or the**  
7           **commission for higher education is necessary to issue and sell**  
8           **bonds for a project if the project or the sale of bonds was approved**  
9           **or authorized by the general assembly in P.L.234-2007 or**  
10           **P.L.182-2009(ss). The board of trustees of the appropriate state**  
11           **educational institution may enter into the necessary contracts to**  
12           **complete the uses, purposes, and projects approved or authorized**  
13           **by the general assembly in P.L.234-2007 or P.L.182-2009(ss).**  
14           (b) **Notwithstanding any other law, including SECTION 21 of**  
15           **this act, no further review, recommendation, or approval by the**  
16           **budget committee, the governor, the budget agency, or the**  
17           **commission for higher education are necessary to allot the money**  
18           **appropriated for construction or rehabilitation and repair in**  
19           **P.L.234-2007 or P.L.182-2009(ss) for the uses, purposes, and**  
20           **projects for which the money was appropriated. The board of**  
21           **trustees of the appropriate state educational institution may enter**  
22           **into the necessary contracts to complete the uses, purposes, and**  
23           **projects contemplated by the appropriation and the budget agency**  
24           **shall allot and pay the necessary amounts to the state educational**

1 institution as needed to comply with the contracts up to the  
2 amounts authorized in P.L.234-2007 and P.L.182-2009(ss). The  
3 appropriations described in this SECTION are not subject to  
4 transfer to any other fund or to transfer, assignment, or  
5 reassignment for any other use or purpose by the state board of  
6 finance, notwithstanding IC 4-9.1-1-7 and IC 4-13-2-23, or by the  
7 budget agency notwithstanding IC 4-12-1-12 or any other law.  
8 Notwithstanding IC 4-13-2-19, the money appropriated by this  
9 subsection does not revert to the state general fund, the build  
10 Indiana fund, or any other fund at the close of any state fiscal year,  
11 but remains available to the Indiana finance authority until the  
12 purposes for which it was appropriated are fulfilled.  
13 Notwithstanding any law, including SECTION 33 of this act, an  
14 action taken by the budget agency or another person to revert an  
15 appropriation described in this subsection is void."

16 Renumber all SECTIONS consecutively.
