- 6 **local public question during a speaking engagement at an event of**
- 7 **an organized community group as authorized by subsection (h), the**
- 8 **employee may assist the superintendent or the superintendent's**
- 9 **designee in presenting information on the local public question**
- 10 **during the speaking engagement, if requested to do so by the**
- 11 **superintendent or the superintendent's designee."**
- 12 Page 2, line 18, strike "directly".
- 13 Page 2, line 22, delete "discussing" and insert "**initiating discussion**

- 16 **initiate a discussion of the local public question at the meeting, the**
- 17 **teacher may acknowledge the issue and direct the parents to a**
- 18 **source of factual information on the local public question."**

- 20 Page 2, line 37, strike "any of the school corporation's facilities" and
- 21 insert "**to provide goods or services to the school corporation**".

- 23 **apply to a person or organization if the person's or organization's**
- 24 **contract or arrangement with the school corporation is solely for**

- 1 **the use of the school corporation's facilities."**
- 2 Page 2, line 40, delete "Except as provided in subsection (h),".
- 3 Page 2, line 40, delete "an attorney," and insert "An attorney,".
- 4 Page 3, delete lines 12 through 19.
- 5 Page 3, line 20, delete "(i)" and insert "**(h)**".
- 6 Page 3, after line 42, begin a new paragraph and insert:
- 7 "SECTION 3. IC 20-46-1-19, AS AMENDED BY P.L.146-2008,
- 8 SECTION 503, IS AMENDED TO READ AS FOLLOWS
- 9 [EFFECTIVE JULY 1, 2011]: Sec. 19. If a majority of the persons who
- 10 voted in the referendum did not vote "yes" on the referendum question:
- 11 (1) the school corporation may not make any levy for its
- 12 referendum tax levy fund; and
- 13 (2) another referendum under this section may not be held for ~~one~~
- 14 **(+) year twenty-three (23) months** after the date of the
- 15 referendum.

- 34 Page 5, line 5, delete "for the use of any of the school corporation's
- 35 facilities" and insert "**to provide goods or services to the school**
- 36 **corporation**".
- 37 Page 5, line 9, after "infraction." insert "**This subsection does not**
- 38 **apply to a person or organization if the person's or organization's**
- 39 **contract or arrangement with the school corporation is solely for**
- 40 **the use of the school corporation's facilities."**
- 41 Page 5, line 10, delete "Except as provided in subsection (g), an"
- 42 and insert "**An**".
- 43 Page 5, delete lines 26 through 30.
- 44 Page 5, line 31, delete "(h)" and insert "**(g)**".
- 45 Renumber all SECTIONS consecutively.
