# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1340 be amended to read as follows:

- 1 Page 2, between lines 32 and 33, begin a new paragraph and insert:
- 2 "SECTION 1. IC 20-19-2-2, AS ADDED BY P.L. 1-2005, SECTION
- 3 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON
- 4 PASSAGE]: Sec. 2. (a) The Indiana state board of education is
- 5 established. The state board consists of:
- 6 (1) the state superintendent; and
- 7 (2) ~~ten (10)~~ **eleven (11)** members appointed by the governor.
- 8 (b) The following provisions apply to members of the state board
- 9 appointed by the governor:
- 10 (1) At least four (4) of the members must be actively employed in
- 11 the schools in Indiana and hold a valid teaching license.
- 12 **(2) At least one (1) of the members must be actively employed**
- 13 **as an area career and technical education director in the**
- 14 **schools in Indiana and hold a valid career and technical**
- 15 **education director license.**
- 16 ~~(2)~~ **(3)** At least one (1) member must be appointed from each
- 17 congressional district in Indiana.
- 18 ~~(3)~~ **(4)** Not more than six (6) members of the state board may be
- 19 appointed from the membership of any one (1) political party.
- 20 ~~(4)~~ **(5)** The term of office of a member begins on July 1. Except as
- 21 provided in subdivision (5), the term of office of a member is four
- 22 (4) years.
- 23 ~~(5)~~ **(6)** The governor may dismiss a member for just cause.
- 24 ~~(6)~~ **(7)** The governor may appoint a member to fill a vacancy

1 occurring on the state board. A member appointed under this  
2 subdivision serves for the remainder of the unexpired term.

3 (c) A quorum consists of six (6) members of the state board. An  
4 action of the state board is not official unless the action is authorized  
5 by at least six (6) members.

6 (d) The state superintendent serves as chairperson of the state board.

7 SECTION 2. IC 20-19-2-4.5 IS ADDED TO THE INDIANA CODE  
8 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**  
9 **UPON PASSAGE]: Sec. 4.5. (a) The advisory committee on career**  
10 **and technical education is established to advise the state board of**  
11 **education on policy matters concerning career and technical**  
12 **education. The advisory committee consists of:**

13 (1) **the state superintendent or the state superintendent's**  
14 **designee; and**

15 (2) **seven (7) members appointed by the state superintendent.**

16 (b) **The following provisions apply to members of the advisory**  
17 **committee on career and technical education:**

18 (1) **At least four (4) of the members must be actively employed**  
19 **as area career and technical education directors in schools in**  
20 **Indiana and hold a valid career and technical education**  
21 **director license.**

22 (2) **Not more than one (1) member may be from any**  
23 **secondary area district in the state.**

24 (3) **Members serve at the pleasure of the state superintendent.**

25 (c) **The state superintendent or the state superintendent's**  
26 **designee serves as the chairperson of the advisory committee on**  
27 **career and technical education."**
