MR. SPEAKER:

I move that House Bill 1406 be amended to read as follows:

- 1 Page 1, line 9, reset in roman "only".
- 2 Page 1, line 11, delete "An institution may" and insert "**However,**
- 3 **a police officer appointed under this chapter may exercise the**
- 4 **police powers granted under this chapter to pursue in fresh pursuit**
- 5 **(as defined in IC 35-33-3-5) and arrest a person who the police**
- 6 **officer reasonably believes has committed an offense on any real**
- 7 **property owned or occupied by the educational institution**
- 8 **employing the police officer, including the streets passing through**
- 9 **or adjacent to the educational institution."**
- 10 Page 1, delete lines 12 through 17.
- 11 Page 2, delete lines 1 through 16.
- 12 Page 2, between lines 20 and 21, begin a new paragraph and insert:
- 13 "SECTION 2. IC 21-17-5-9 IS ADDED TO THE INDIANA CODE
- 14 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 15 1, 2011]: **Sec. 9. Police departments and police officers subject to**
- 16 **this chapter are subject to the same record keeping, reporting, and**
- 17 **public access requirements as the sheriff in the county where the**
- 18 **educational institution is located, including the requirements in**
- 19 **IC 5-14-3-5."**
- 20 Page 2, line 23, after "(a)" insert "**This section applies only to a**
- 21 **police officer who meets the minimum basic training and**
- 22 **educational requirements adopted by the law enforcement training**
- 23 **board under IC 5-2-1-9 as necessary for employment as a law**
- 24 **enforcement officer.**

- 1           **(b)".**
- 2           Page 2, line 24, reset in roman "only".
- 3           Page 2, line 24, delete "as follows:".
- 4           Page 2, line 25, delete "(1) A police officer may exercise the
- 5           officer's powers".
- 6           Page 2, run in lines 24 and 25.
- 7           Page 2, line 32, after "involved." insert **"However, a police officer**
- 8           **may exercise the police powers granted under this chapter to**
- 9           **pursue in fresh pursuit (as defined in IC 35-33-3-5) and arrest a**
- 10           **person who the police officer reasonably believes has committed an**
- 11           **offense on any real property owned or occupied by the state**
- 12           **educational institution employing the police officer, including the**
- 13           **streets passing through or adjacent to the educational institution."**
- 14           Page 2, delete lines 33 through 42, begin a new paragraph and
- 15           insert:
- 16           "SECTION 4. IC 21-39-4-8 IS ADDED TO THE INDIANA CODE
- 17           AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 18           1, 2011]: **Sec. 8. Police departments and police officers subject to**
- 19           **this chapter are subject to the same record keeping, reporting, and**
- 20           **public access requirements as the sheriff in the county where the**
- 21           **state educational institution is located, including the requirements**
- 22           **in IC 5-14-3-5."**
- 23           Delete page 3.
- 24           Re-number all SECTIONS consecutively.
