MR. SPEAKER:

I move that Engrossed Senate Bill 85 be amended to read as follows:

- 1 Page 3, after line 17, begin a new paragraph and insert:
2 "SECTION 2. IC 9-19-13-2 IS AMENDED TO READ AS
3 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 2. An officer or
4 employee of a school corporation who:
5 (1) violates any of the rules, **including those adopted as**
6 **required by IC 20-27-3-6.5**, adopted by the state school bus
7 committee concerning the design and operation of school buses;
8 or
9 (2) fails to include an obligation to comply with those rules in a
10 contract executed by the officer or employee on behalf of a school
11 corporation;
12 is guilty of misconduct and subject to removal from office or
13 employment.
14 SECTION 3. IC 9-19-13-3 IS AMENDED TO READ AS
15 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 3. A person operating
16 a school bus under contract with a school corporation who fails to
17 comply with any of the rules, **including those adopted as required by**
18 **IC 20-27-3-6.5**, adopted by the state school bus committee concerning
19 the design and operation of school buses is guilty of breach of contract.
20 The contract may be canceled after notice and hearing by responsible
21 officers of the school corporation.
22 SECTION 4. IC 20-27-3-3, AS ADDED BY P.L.1-2005, SECTION
23 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,

1 2011]; Sec. 3. (a) The committee:
2 (1) shall hold one (1) regular meeting each ~~month~~; **quarter**; and
3 (2) may hold special meetings as the chairperson considers
4 necessary.
5 (b) Four (4) voting members of the committee constitute a quorum
6 for the transaction of official business.
7 SECTION 5. IC 20-27-3-6.5 IS ADDED TO THE INDIANA CODE
8 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
9 1, 2011]: **Sec. 6.5. (a) The committee shall adopt and enforce rules
10 under IC 4-22-2 to require that a person operating a school bus
11 that is equipped with safety belts meeting the standards set forth
12 in IC 9-19-10-2 provide instruction to the passengers on the school
13 bus at least one (1) time a semester on the proper fastening of the
14 safety belt about the passenger's body.**
15 **(b) The committee shall adopt and enforce rules under IC 4-22-2
16 to require that a person operating a school bus conduct a school
17 bus passenger evacuation drill at least one (1) time a semester."**
18 Renumber all SECTIONS consecutively.
