MR. SPEAKER:

I move that Engrossed Senate Bill 532 be amended to read as follows:

- 1 Page 3, between lines 18 and 19, begin a new paragraph and insert:
- 2 "SECTION 3. IC 14-8-2-169 IS AMENDED TO READ AS
- 3 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 169. (a) "Motorboat",
- 4 for purposes of IC 14-15, except as provided in subsection (c), means
- 5 a watercraft propelled by:
- 6 (1) an internal combustion, steam, or electrical inboard or
- 7 outboard motor or engine; or
- 8 (2) any mechanical means.
- 9 (b) The term includes sailboats that are equipped with a motor or an
- 10 engine described in subsection (a) when the motor or engine is in
- 11 operation, whether or not the sails are hoisted.
- 12 (c) "Motorboat", for purposes of IC 14-15-11, has the meaning set
- 13 forth in IC 14-15-11-6.
- 14 (d) The term includes a personal watercraft (as defined in section
- 15 202.5 of this chapter).
- 16 (e) **"Motorboat", for purposes of IC 14-22-9-11, has the**
- 17 **meaning set forth in IC 14-22-9-11."**
- 18 Page 5, between lines 18 and 19, begin a new paragraph and insert:
- 19 "SECTION 8. IC 14-22-9-1 IS AMENDED TO READ AS
- 20 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 1. (a) Except as
- 21 allowed by ~~section~~ **sections 3 and 11** of this chapter, a person may not
- 22 take fish from waters containing state owned fish, waters of the state,
- 23 or boundary waters of the state by the following:
- 24 (1) Means of:

- 1 (A) a weir;
 2 (B) an electric current;
 3 (C) dynamite or other explosive;
 4 (D) a net;
 5 (E) a seine;
 6 (F) a trap; or
 7 (G) any other substance that has a tendency to stupefy or
 8 poison fish.
- 9 (2) Means of the following:
- 10 (A) A firearm.
 11 (B) A crossbow.
 12 (C) The hands alone.
- 13 (b) The methods or devices in this section may be possessed and
 14 used:
- 15 (1) under special permit issued by the director under rules that the
 16 director provides; or
 17 (2) as otherwise provided by law.
- 18 SECTION 9. IC 14-22-9-11 IS ADDED TO THE INDIANA CODE
 19 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 20 1, 2011]: **Sec. 11. (a) As used in this section, "motorboat" means a
 21 watercraft propelled by:**
- 22 (1) **an internal combustion, steam, or electrical inboard or
 23 outboard motor or engine; or**
 24 (2) **any mechanical means.**
- 25 **The term does not include a personal watercraft.**
- 26 (b) **The department shall establish and implement a pilot
 27 program for the purpose of containing and reducing invasive
 28 animal species in the Wabash River. In developing this pilot
 29 program, the department may:**
- 30 (1) **allow the taking of a specific invasive animal species by a
 31 means described in section 1(2) of this chapter;**
 32 (2) **may require the use of ammunition described in 50 CFR
 33 20.21(j); or**
 34 (3) **require a hunting or fishing license under IC 14-22-12-1.**
- 35 (c) **312 IAC 9-2-2(d), as in effect July 1, 2011, does not apply to
 36 this section."**
- 37 Page 17, after line 5, begin a new paragraph and insert:
 38 "SECTION 32. [EFFECTIVE JULY 1, 2011] (a) **The department
 39 of natural resources may adopt emergency rules to implement
 40 IC 14-22-9-11, as added by this act, in the manner provided for the
 41 adoption of emergency rules under IC 4-22-2-37.1.**
- 42 (b) **An emergency rule adopted under this SECTION expires on
 43 the earlier of the following:**
- 44 (1) **The date the natural resources commission adopts
 45 permanent rules under IC 4-22-2 to replace the emergency
 46 rules.**
 47 (2) **July 1, 2012.**

- 1 **(c) This SECTION expires July 1, 2012."**
- 2 Renumber all SECTIONS consecutively.
