DIGEST OF HB 1275 (Updated February 17, 2011 11:13 am - DI 75)

**Citations Affected:** IC 6-3.5; IC 36-1.

**Synopsis:** Local transfers between funds. Authorizes a county, city, or town to transfer money from its economic development income tax fund or rainy day fund to its general fund or any appropriated funds of the county, city, or town. Requires a county, city, or town to make the transfer by adopting an ordinance or resolution.

**Effective:** July 1, 2011.

## HOUSE BILL No. 1275



A BILL FOR AN ACT to amend the Indiana Code concerning local government.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 6-3.5-7-12.7 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2011]: **Sec. 12.7. A county, city, or town may**  
4 **at any time, by ordinance or resolution, transfer to:**

- 5 (1) **its general fund; or**  
6 (2) **any other appropriated funds of the county, city, or town;**  
7 **money that has been deposited in the economic development**  
8 **income tax fund established by the county, city, or town under**  
9 **section 13.1 of this chapter.**

10 SECTION 2. IC 36-1-8-5.1 IS AMENDED TO READ AS  
11 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 5.1. (a) A political  
12 subdivision may establish a rainy day fund by the adoption of:

- 13 (1) an ordinance, in the case of a county, city, or town; or  
14 (2) a resolution, in the case of any other political subdivision.  
15 (b) An ordinance or a resolution adopted under this section must  
16 specify the following:  
17 (1) The purposes of the rainy day fund.

- 1 (2) The sources of funding for the rainy day fund, which may
- 2 include the following:
- 3 (A) Unused and unencumbered funds under:
- 4 (i) section 5 of this chapter;
- 5 (ii) IC 6-3.5-1.1-21.1;
- 6 (iii) IC 6-3.5-6-17.3; or
- 7 (iv) IC 6-3.5-7-17.3.
- 8 (B) Any other funding source:
- 9 (i) specified in the ordinance or resolution adopted under
- 10 this section; and
- 11 (ii) not otherwise prohibited by law.
- 12 (c) The rainy day fund is subject to the same appropriation process
- 13 as other funds that receive tax money.
- 14 (d) In any fiscal year, a political subdivision may transfer under
- 15 section 5 of this chapter not more than ten percent (10%) of the
- 16 political subdivision's total annual budget for that fiscal year, adopted
- 17 under IC 6-1.1-17, to the rainy day fund.
- 18 (e) A political subdivision may use only the funding sources
- 19 specified in subsection (b)(2)(A) or in the ordinance or resolution
- 20 establishing the rainy day fund. The political subdivision may adopt a
- 21 subsequent ordinance or resolution authorizing the use of another
- 22 funding source.
- 23 (f) The department of local government finance may not reduce the
- 24 actual or maximum permissible levy of a political subdivision as a
- 25 result of a balance in the rainy day fund of the political subdivision.
- 26 (g) **A county, city, or town may at any time, by ordinance or**
- 27 **resolution, transfer to:**
- 28 **(1) its general fund; or**
- 29 **(2) any other appropriated funds of the county, city, or town;**
- 30 **money that has been deposited in the rainy day fund of the county,**
- 31 **city, or town.**
