HOUSE BILL No. 1451

A BILL FOR AN ACT concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE JULY 1, 2011] (a) **Before January 1,**
2 **2012, the environmental quality service council established by**
3 **IC 13-13-7-1 shall do the following:**

4 (1) **Conduct a study on the following subjects:**

5 (A) **The actual and potential air emissions created by the**
6 **distillation of mint.**

7 (B) **Whether the distillation of mint should be considered**
8 **a farming operation (as defined in 326 IAC 1-2-28) for the**
9 **purpose of requiring a permit under IC 13-17.**

10 (2) **Prepare a report on the subjects under subdivision (1) and**
11 **advise the department of environmental management on the**
12 **feasibility of establishing permit requirements for mint**
13 **distillation operations under IC 13-17.**

14 (b) **The department of environmental management may not**
15 **impose any permit requirements under IC 13-17 for mint**
16 **distillation operations before receiving the report and**
17 **recommendations from the environmental quality service council.**
