MR. SPEAKER:

*Your Committee on Elections and Apportionment, to which was referred House Bill 1601, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning the
- 3 general assembly.
- 4 Page 1, delete lines 1 through 2, begin a new paragraph and insert:
- 5 "SECTION 1. IC 2-1-9-1 IS AMENDED TO READ AS FOLLOWS
- 6 [EFFECTIVE JULY 1, 2011]: Sec. 1. All terms and references to
- 7 geographic units made in the descriptions of districts in this article:
- 8 (1) have the same meanings as the terms have when used by the
- 9 United States Department of Commerce, Bureau of the Census,
- 10 in reporting the ~~2000~~ 2010 decennial census of Indiana as
- 11 supplemented by geographic information compiled and
- 12 documented by the legislative services agency; and
- 13 (2) describe the same geographical boundaries as depicted by

1 maps included in the GIS.

2 SECTION 2. IC 2-1-9-3 IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2011]: Sec. 3. As used in this chapter, "GIS"
4 refers to the geographic information system maintained by the office
5 that contains the following information:

6 (1) Geographic and population information provided in the
7 official census report to the state by the United States Department
8 of Commerce, Bureau of the Census, in reporting the ~~2000~~ **2010**
9 decennial census of Indiana.

10 (2) Election history and supplemental geographic information
11 compiled by the legislative services agency.

12 SECTION 3. IC 2-1-9-4 IS AMENDED TO READ AS FOLLOWS
13 [EFFECTIVE JULY 1, 2011]: Sec. 4. As used in this chapter, "house
14 district" refers to a district of the house of representatives of the general
15 assembly described in ~~IC 2-1-10~~ **IC 2-1-12**.

16 SECTION 4. IC 2-1-9-6 IS AMENDED TO READ AS FOLLOWS
17 [EFFECTIVE JULY 1, 2011]: Sec. 6. As used in this chapter, "senate
18 district" refers to a district of the senate of the general assembly
19 described in ~~IC 2-1-11~~ **IC 2-1-13**.

20 SECTION 5. IC 2-1-9-7 IS AMENDED TO READ AS FOLLOWS
21 [EFFECTIVE JULY 1, 2011]: Sec. 7. (a) Any part of Indiana that has
22 not been described as included in a house or senate district is included
23 within the house or senate district that:

24 (1) is contiguous to the part; and
25 (2) contains the least population of all house or senate districts
26 contiguous to that part according to the ~~2000~~ **2010** decennial
27 census of Indiana.

28 (b) If any part of Indiana is described as being in more than one (1)
29 house or senate district, the part is included within the house or senate
30 district that:

31 (1) is one (1) of the house or senate districts in which the part is
32 listed in ~~IC 2-1-10~~ **IC 2-1-12** or ~~IC 2-1-11~~, **IC 2-1-13**, whichever
33 is applicable;
34 (2) is contiguous to the part; and
35 (3) contains the least population according to the 2000 decennial
36 census of Indiana.

37 (c) If any part of Indiana:

38 (1) is described in ~~IC 2-1-10~~ **IC 2-1-12** or ~~IC 2-1-11~~ **IC 2-1-13** as

1 being in one (1) house or senate district; and
 2 (2) entirely surrounded by another house or senate district;
 3 the part shall be incorporated into the house or senate district that
 4 surrounds the part.

5 (d) If any part of Indiana:

6 (1) is described as being in one (1) house or senate district; and
 7 (2) is not contiguous to another part of the house or senate district
 8 that contains the majority of the population in the house or senate
 9 district;

10 the part is included with the contiguous house or senate district that
 11 contains the least population according to the ~~2000~~ **2010** decennial
 12 census of Indiana.

13 SECTION 6. IC 2-1-9-8 IS AMENDED TO READ AS FOLLOWS
 14 [EFFECTIVE JULY 1, 2011]: Sec. 8. Indiana is divided into one
 15 hundred (100) house districts as described in ~~IC 2-1-10~~ **IC 2-1-12**.
 16 From each of these districts there shall be elected one (1)
 17 representative of the house of representatives of the Indiana general
 18 assembly.

19 SECTION 7. IC 2-1-9-9 IS AMENDED TO READ AS FOLLOWS
 20 [EFFECTIVE JULY 1, 2011]: Sec. 9. (a) Indiana is divided into fifty
 21 (50) senate districts as described in ~~IC 2-1-11~~ **IC 2-1-13**. From each
 22 of these districts there shall be elected one (1) senator of the senate of
 23 the Indiana general assembly.

24 (b) Each senator elected in the general election in ~~2000~~ **2010** for a
 25 full four (4) year term shall continue to hold office until the term for
 26 which the senator was elected has expired by limitation, and the senator
 27 shall represent the district established under ~~IC 2-1-11~~ **IC 2-1-13** in
 28 which the senator's legal residence is located.

29 SECTION 8. IC 2-1-9-10 IS AMENDED TO READ AS FOLLOWS
 30 [EFFECTIVE JULY 1, 2011]: Sec. 10. The legislative services agency
 31 shall separately maintain and preserve in the GIS the descriptions and
 32 maps included in the ~~2000~~ **2010** decennial census of Indiana. The
 33 legislative services agency shall make those descriptions and maps
 34 available for public inspection during regular office hours and on the
 35 Internet.

36 SECTION 9. IC 2-1-9-11 IS AMENDED TO READ AS FOLLOWS
 37 [EFFECTIVE JULY 1, 2011]: Sec. 11. The official report and all
 38 official documents relating to the report of the ~~2000~~ **2010** decennial

1 census are incorporated by reference into this article.

2 SECTION 10. IC 2-1-12 IS ADDED TO THE INDIANA CODE AS
3 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
