MR. SPEAKER:

Your Committee on Roads and Transportation, to which was referred Senate Bill 101, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:

- 1 Page 1, line 1, delete "SECTION 1. IC 9-24-3-3 IS AMENDED TO
- 2 READ AS FOLLOWS" and insert the following:
- 3 "SECTION 1. IC 9-24-3-1, AS AMENDED BY P.L.101-2009,
- 4 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 5 UPON PASSAGE]: Sec. 1. Except as otherwise provided in this article,
- 6 the bureau shall issue an operator's license to an individual who meets
- 7 the following conditions:
- 8 (1) Satisfies the age requirements set forth in section ~~2~~ or 2.5 or
- 9 2.7 of this chapter.
- 10 (2) Makes proper application to the bureau under IC 9-24-9 upon
- 11 a form prescribed by the bureau. ~~Effective July 1, 2010;~~ The form
- 12 must include a verification concerning the number of hours of
- 13 supervised driving practice that the individual has completed if
- 14 the individual is required under section 2.5 or 2.7 of this chapter
- 15 to complete a certain number of hours of supervised driving
- 16 practice in order to receive an operator's license.

1 (3) Satisfactorily passes the examination and tests required for
2 issuance of an operator's license under IC 9-24-10.

3 (4) Pays the fee prescribed by IC 9-29-9.

4 SECTION 2. IC 9-24-3-2.5, AS ADDED BY P.L.101-2009,
5 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
6 UPON PASSAGE]: Sec. 2.5. (a) This section applies beginning July 1,
7 2010, **and expires June 30, 2011.**

8 (b) Except as provided in section 3 of this chapter, an individual
9 must satisfy the requirements set forth in one (1) of the following
10 subdivisions to receive an operator's license:

11 (1) The individual meets the following conditions:

12 (A) Is at least sixteen (16) years and one hundred eighty (180)
13 days of age.

14 (B) Has held a valid learner's permit for at least one hundred
15 eighty (180) days.

16 (C) Obtains an instructor's certification that the individual has
17 satisfactorily completed an approved driver education course.

18 (D) Passes the required examination.

19 (E) Completes at least fifty (50) hours of supervised driving
20 practice, of which at least ten (10) hours are nighttime driving,
21 with:

22 (i) a licensed instructor or a licensed driver who is at least
23 twenty-five (25) years of age; or

24 (ii) the spouse of the individual who is at least twenty-one
25 (21) years of age.

26 (2) The individual meets the following conditions:

27 (A) Is at least sixteen (16) years and two hundred seventy
28 (270) days of age.

29 (B) Has held a valid learner's permit for at least one hundred
30 eighty (180) days.

31 (C) Passes the required examination.

32 (D) Completes at least fifty (50) hours of supervised driving
33 practice, of which at least ten (10) hours are nighttime driving,
34 with:

35 (i) a licensed instructor or a licensed driver who is at least
36 twenty-five (25) years of age; or

37 (ii) the spouse of the individual who is at least twenty-one
38 (21) years of age.

- 1 (3) The individual meets the following conditions:
 2 (A) Is at least sixteen (16) years and one hundred eighty (180)
 3 days of age but less than eighteen (18) years of age.
 4 (B) Has previously been a nonresident of Indiana, but, at the
 5 time of application, qualifies as an Indiana resident.
 6 (C) Holds an unrevoked driver's license, excluding a learner's
 7 permit or the equivalent, in the state or a combination of states
 8 in which the individual formerly resided for at least one
 9 hundred eighty (180) days.
 10 (D) Passes the required examination.

- 11 (4) The individual meets the following conditions:
 12 (A) Is at least eighteen (18) years of age.
 13 (B) Has previously been a nonresident of Indiana but, at the
 14 time of application, qualifies as an Indiana resident.
 15 (C) Has held an unrevoked operator's, chauffeur's, commercial
 16 driver's, or public passenger chauffeur's license from the state
 17 of prior residence.
 18 (D) Passes the required examination.

19 SECTION 3. IC 9-24-3-2.7 IS ADDED TO THE INDIANA CODE
 20 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**
 21 **UPON PASSAGE]: Sec. 2.7. (a) This section applies beginning July**
 22 **1, 2011.**

23 **(b) Except as provided in section 3 of this chapter, an individual**
 24 **must satisfy the requirements set forth in one (1) of the following**
 25 **subdivisions to receive an operator's license:**

- 26 **(1) The individual meets the following conditions:**
 27 **(A) Is at least sixteen (16) years and ninety (90) days of age.**
 28 **(B) Has held a valid learner's permit for at least one**
 29 **hundred eighty (180) days.**
 30 **(C) Obtains an instructor's certification that the individual**
 31 **has satisfactorily completed an approved driver education**
 32 **course.**
 33 **(D) Passes the required examination.**
 34 **(E) Completes at least fifty (50) hours of supervised driving**
 35 **practice, of which at least ten (10) hours are nighttime**
 36 **driving, with:**
 37 **(i) a licensed instructor or a licensed driver who is at**
 38 **least twenty-five (25) years of age; or**

- 1 (ii) the spouse of the individual who is at least twenty-one
- 2 (21) years of age.
- 3 **(2) The individual meets the following conditions:**
- 4 **(A) Is at least sixteen (16) years and two hundred seventy**
- 5 **(270) days of age.**
- 6 **(B) Has held a valid learner's permit for at least one**
- 7 **hundred eighty (180) days.**
- 8 **(C) Passes the required examination.**
- 9 **(D) Completes at least fifty (50) hours of supervised**
- 10 **driving practice, of which at least ten (10) hours are**
- 11 **nighttime driving, with:**
- 12 **(i) a licensed instructor or a licensed driver who is at**
- 13 **least twenty-five (25) years of age; or**
- 14 **(ii) the spouse of the individual who is at least twenty-one**
- 15 **(21) years of age.**
- 16 **(3) The individual meets the following conditions:**
- 17 **(A) Is at least sixteen (16) years and one hundred eighty**
- 18 **(180) days of age but less than eighteen (18) years of age.**

- 22 **learner's permit or the equivalent, in the state or a**
- 23 **combination of states in which the individual formerly**
- 24 **resided for at least one hundred eighty (180) days.**
- 25 **(D) Passes the required examination.**
- 26 **(4) The individual meets the following conditions:**
- 27 **(A) Is at least eighteen (18) years of age.**
- 28 **(B) Has previously been a nonresident of Indiana but, at**
- 29 **the time of application, qualifies as an Indiana resident.**
- 30 **(C) Has held an unrevoked operator's, chauffeur's,**
- 31 **commercial driver's, or public passenger chauffeur's**
- 32 **license from the state of prior residence.**
- 33 **(D) Passes the required examination."**

- 2 Page 2, line 4, after "years" insert "**and ninety (90) days**".
- 3 Renumber all SECTIONS consecutively.
