MR. SPEAKER:

*Your Committee on Public Policy, to which was referred Senate Bill 340, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 2-5-31.9 IS ADDED TO THE INDIANA CODE
4 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2011]:
6 **Chapter 31.9. Charity Gaming Study Committee**
7 **Sec. 1. The charity gaming study committee is established.**
8 **Sec. 2. (a) The committee consists of eleven (11) members**
9 **appointed as follows:**
10 **(1) The chairperson of the house of representatives committee**
11 **on public policy.**
12 **(2) The ranking minority member of the house of**
13 **representatives committee on public policy.**
14 **(3) The chairperson of the senate committee on public policy.**
15 **(4) The ranking minority member of the senate committee on**

- 1 **public policy.**
- 2 **(5) One (1) member of the house of representatives appointed**
- 3 **by the speaker of the house of representatives.**
- 4 **(6) One (1) member of the senate appointed by the president**
- 5 **pro tempore of the senate.**
- 6 **(7) One (1) individual who is not a member of the general**
- 7 **assembly appointed by the speaker of the house of**
- 8 **representatives.**
- 9 **(8) One (1) individual who is not a member of the general**
- 10 **assembly appointed by the minority leader of the house of**
- 11 **representatives.**
- 12 **(9) One (1) individual who is not a member of the general**
- 13 **assembly appointed by the president pro tempore of the**
- 14 **senate.**
- 15 **(10) One (1) individual who is not a member of the general**
- 16 **assembly appointed by the minority leader of the senate.**
- 17 **(11) The executive director of the Indiana gaming**
- 18 **commission, or the executive director's designee, who serves**
- 19 **as an ex officio nonvoting member.**
- 20 **(b) Each member of the committee who is not:**
- 21 **(1) a member of the general assembly; or**
- 22 **(2) appointed under subsection (a)(11);**
- 23 **must be a member of a qualified organization (as defined under**
- 24 **IC 4-32.2-2) that has engaged in charity gaming under a license**
- 25 **issued after December 31, 2009.**
- 26 **Sec. 3. The chairman of the legislative council shall appoint a**
- 27 **legislative member of the committee to serve as chair of the**
- 28 **committee. Whenever there is a new chairman of the legislative**
- 29 **council, the new chairman may remove the chair of the committee**
- 30 **and appoint another chair.**
- 31 **Sec. 4. If a legislative member of the committee ceases to be a**
- 32 **member of the chamber from which the member was appointed,**
- 33 **the member also ceases to be a member of the committee.**
- 34 **Sec. 5. A legislative member of the committee may be removed**
- 35 **at any time by the appointing authority who appointed the**
- 36 **legislative member.**
- 37 **Sec. 6. If a vacancy exists on the committee, the appointing**
- 38 **authority who appointed the former member whose position is**

1 vacant shall appoint an individual to fill the vacancy.

2 **Sec. 7.** The committee shall submit a final report of the results
3 of its study to the legislative council before November 1, 2011. The
4 report must be in an electronic format under IC 5-14-6.

5 **Sec. 8. (a)** Except as provided in subsection (b), each member of
6 the committee is entitled to receive the same per diem, mileage, and
7 travel allowances paid to individuals who serve as legislative and
8 lay members, respectively, of interim study committees established
9 by the legislative council.

10 **(b)** Each member of the committee who is a state employee but
11 not a member of the general assembly is entitled to the following:

12 **(1)** Reimbursement for traveling expenses as provided under
13 IC 4-13-1-4.

14 **(2)** Other expenses actually incurred in connection with the
15 member's duties as provided in the state policies and
16 procedures established by the Indiana department of
17 administration and approved by the budget agency.

18 **Sec. 9.** The affirmative votes of a majority of the voting
19 members appointed to the committee are required for the
20 committee to take action on any measure, including the final
21 report.

22 **Sec. 10.** Except as otherwise specifically provided by this
23 chapter, the committee shall operate under the rules of the
24 legislative council. All funds necessary to carry out this chapter
25 shall be paid from appropriations to the legislative council and the
26 legislative services agency.

27 **Sec. 11. (a)** The committee shall study the following:

28 **(1)** The requirements for obtaining a charity gaming license.

29 **(2)** Whether qualified organizations should be permitted to
30 use charity gaming proceeds to pay the salaries and benefits
31 of the qualified organization's employees.

32 **(3)** The reporting requirements for conducting charity gaming
33 events.

34 **(4)** Whether qualified organizations should be permitted to
35 conduct charity gaming events more frequently.

36 **(5)** The hours in which charity gaming events may be
37 conducted.

38 **(6)** Issues related to licensing and regulating national

- 1 **organizations and their affiliates.**
