## MR. SPEAKER:

*Your Committee on Public Policy, to which was referred Senate Bill 292, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 2, between lines 16 and 17, begin a new paragraph and insert:
- 2 "Sec. 2. For purposes of this chapter, "lawful discharge" means
- 3 the following:
- 4 (1) A discharge of a firearm in self-defense as provided in
- 5 IC 35-41-3-2.
- 6 (2) A discharge of a firearm in a shooting range (as defined in
- 7 IC 14-22-31.5-3).
- 8 (3) A discharge of a firearm while attending a firearms
- 9 instruction course.
- 10 (4) A discharge of a firearm in a properly zoned indoor firing
- 11 range.
- 12 (5) A discharge of a firearm in or at a conservation club
- 13 whose mission includes education of safe firearms practice.
- 14 (6) A discharge of a firearm while engaged in a legal hunting

- 1           **activity, unless the discharge is prohibited or restricted by**
- 2           **zoning or a general ordinance."**
- 3           Page 2, line 17, delete "2." and insert "3."
- 4           Page 2, line 17, delete "4" and insert "5".
- 5           Page 2, line 27, delete "3." and insert "4."
- 6           Page 2, line 33, delete "section 2" and insert "section 3".
- 7           Page 2, line 36, delete "4." and insert "5."
- 8           Page 3, line 41, delete "or".
- 9           Page 4, line 1, delete "firearm." and insert "**firearm; or**".
- 10          Page 4, between lines 1 and 2, begin a new line block indented and
- 11          insert:
- 12          **"(10) the promoters or organizers of an event occurring on**
- 13          **property leased from a political subdivision or municipal**
- 14          **corporation from:**
- 15                **(A) establishing, at the promoter's or organizer's own**
- 16                **discretion, rules of conduct or admission upon which**
- 17                **attendance at or participation in an event is conditioned;**
- 18                **or**
- 19                **(B) the implementation or enforcement of rules of conduct**
- 20                **or admission in connection with the event by a political**
- 21                **subdivision or municipal corporation;**
- 22          **(11) the enactment or enforcement of a provision prohibiting**
- 23          **or restricting the possession of a firearm in a hospital**
- 24          **established and operated under IC 16-22-2 or IC 16-23;**
- 25          **(12) a unit from using the unit's planing and zoning powers**
- 26          **under IC 36-7-4 to prohibit the sale of firearms within two**
- 27          **hundred (200) feet of a school by a person having a business**
- 28          **that did not sell firearms within two hundred (200) feet of a**
- 29          **school before April 1, 1994; or**
- 30          **(13) a:**
- 31                **(A) city or town; or**
- 32                **(B) consolidated city, including:**
- 33                    **(i) all the territory that comprised the first class city**
- 34                    **before it became a consolidated city under IC 36-3-1;**
- 35                    **and**
- 36                    **(ii) the included towns (as defined in IC 36-3-1-7).**
- 37          **This clause does apply to the territory of an excluded city**
- 38          **(as defined in IC 36-3-1-7);**

1           **from enacting or enforcing a provision prohibiting or**  
2           **restricting the lawful discharge of a firearm at a shooting**  
3           **range.".**

4           Page 4, line 2, delete "5." and insert "6".

5           Page 4, line 9, delete "6." and insert "7".

6           Page 4, line 10, delete "5" and insert "6".

7           Page 4, line 20, delete "5" and insert "6".

8           Page 4, line 31, delete "7." and insert "8".

9           Page 4, line 31, delete "5" and insert "6".

10          Renumber all SECTIONS consecutively.
