*Your Committee on Elections and Apportionment, to which was referred House Bill 1074, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 2, line 2, delete "July 1," and insert "**January 1**,".
- 2 Page 2, line 7, delete "July 1," and insert "**January 1**,".
- 3 Page 11, line 40, reset in roman "January".
- 4 Page 11, line 41, before "or" reset in roman "1".
- 5 Page 11, line 41, strike "July 1".
- 6 Page 15, line 24, delete "July 1" and insert "**January 1**".
- 7 Page 15, line 24, after "following" delete "the" and insert "**their**".
- 8 Page 19, line 25, strike "July".
- 9 Page 19, line 26, strike "1" and insert "**January 1**".
- 10 Page 20, between lines 31 and 32, begin a new paragraph and insert:
- 11 "SECTION 15. IC 20-23-8-10, AS ADDED BY P.L.1-2005,
- 12 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 13 JULY 1, 2011]: Sec. 10. (a) A change in a plan may be initiated by one
- 14 (1) of the following procedures:

1 (1) By filing a petition signed by at least ~~twenty percent (20%)~~
 2 **ten percent (10%)** of the voters of the school corporation with
 3 the clerk of the circuit court.

4 (2) By a resolution adopted by the governing body of the school
 5 corporation.

6 (3) By ordinance adopted by a city legislative body under section
 7 13 of this chapter.

8 (b) A petition, resolution, or ordinance must set forth a description
 9 of the plan that conforms with section 7 of this chapter.

10 (c) ~~Except as provided in subsection (a)(1), in a city having a~~
 11 ~~population of more than fifty-nine thousand seven hundred (59,700)~~
 12 ~~but less than sixty-five thousand (65,000), a change in a plan may be~~
 13 ~~initiated by filing a petition signed by ten percent (10%) or more of the~~
 14 ~~voters of the school corporation with the clerk of the circuit court."~~

15 Page 22, line 2, strike "July 1" and insert "**January 1**".

16 Page 25, line 7, strike "July 1" and insert "**January 1**".

17 Page 25, delete lines 17 through 42.

18 Page 26, delete lines 1 through 10.

19 Page 27, line 8, strike "July 1 of the year".

20 Page 27, line 8, before "following" insert "**January 1 immediately**".

21 Page 28, after line 12, begin a new paragraph and insert:

22 "SECTION 31. [EFFECTIVE JULY 1, 2011] **(a) The county**
 23 **election board of St. Joseph County shall place the following public**
 24 **question on the November 2011 municipal election ballot in the city**
 25 **of Mishawaka in St. Joseph County:**

26 "Should the method of choosing the members of the governing
 27 body of the School City of Mishawaka be changed?".

28 **(b) The county election board shall tabulate the votes cast on the**
 29 **public question described in this SECTION and certify the results**
 30 **under IC 3-12-4-9. The circuit court clerk shall send a copy of the**
 31 **certification required by this subsection to the department of**
 32 **education.**

33 **(c) IC 3 applies to the public question placed on the ballot under**
 34 **this SECTION to the extent IC 3 is not inconsistent with this**

- 2 **(d) This SECTION expires July 1, 2012."**
- 3 Renumber all SECTIONS consecutively.
 (Reference is to HB 1074 as introduced.)
