- 4 UPON PASSAGE]: **Sec. 8. (a) Notwithstanding IC 9-24-10-4(d),**
- 5 **IC 9-27-6-6(b), IC 9-27-6-7(b), IC 9-27-6-8(b), IC 9-27-6-9(b),**
- 6 **IC 9-27-6-11, and IC 9-29-9-3.5, the bureau shall carry out the**
- 7 **duties imposed upon it under IC 9-24-10-4(d), IC 9-27-6-6(b),**
- 8 **IC 9-27-6-7(b), IC 9-27-6-8(b), IC 9-27-6-9(b), IC 9-27-6-11, and**
- 9 **IC 9-29-9-3.5, through the adoption of interim written guidelines**
- 10 **approved by the commissioner of the bureau.**
- 11 **(b) This section expires December 31, 2014."**
