*Your Committee on Public Policy, to which was referred House Bill 1132, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 7.1-2-3-34 IS ADDED TO THE INDIANA CODE
- 4 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY
- 5 1, 2011]: **Sec. 34. (a) The commission shall submit a report, not**
- 6 **later than November 1, 2011, to the general assembly concerning**
- 7 **the viability and efficacy of instituting a policy to permit the direct**
- 8 **shipment of wine to consumers in Indiana. The report must be in**
- 9 **an electronic format under IC 5-14-6.**
- 10 **(b) The report under subsection (a) must include the following:**
- 11 **(1) An evaluation of the best practices of each state, including**
- 12 **the District of Columbia, that allows direct wine shipment.**
- 13 **(2) An evaluation of related fiscal, tax, and other public policy**
- 14 **and regulatory issues related to direct wine shipment.**
- 15 **(3) A determination regarding:**
- 16 **(A) the best practices for preventing access by minors to**

1 **wine shipped directly to consumers;**
 2 **(B) any significant increase or decrease in access to or**
 3 **demand for wine by minors that has been documented as**
 4 **related to direct wine shipment laws;**
 5 **(C) the best practices for collecting tax revenues on wine;**
 6 **(D) the benefits and costs of direct wine shipment to**
 7 **consumers; and**
 8 **(E) the effect of direct wine shipment laws on in-state**
 9 **wineries, alcoholic beverage licensees, and other local**
 10 **businesses.**

11 **(c) This section expires July 1, 2012."**
