
SENATE BILL No. 412

DIGEST OF INTRODUCED BILL

Citations Affected: IC 13-11-2; IC 13-15-1-2; IC 13-18-24.

Synopsis: Ballast water and sediment in oceangoing vessels. Provides that, beginning July 1, 2012, each oceangoing vessel engaging in port operations in Indiana must obtain a permit from the department of environmental management (IDEM). Allows IDEM to issue a permit only if the applicant can demonstrate that the vessel will not discharge aquatic nuisance species, or if the vessel discharges ballast water or sediment, that the operator of the vessel will use environmentally sound technology and methods to prevent the discharge of aquatic nuisance species. Requires IDEM to establish a ballast water and sediment inspection program that ensures that aquatic nuisance species do not enter the waters of Indiana. Requires the water pollution control board to adopt rules to implement these provisions.

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 13-11-2-9.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2011]: **Sec. 9.5. "Aquatic nuisance species", for purposes of**
4 **IC 13-18-24, means a nonindigenous species that threatens any of**
5 **the following in waters infested with the nonindigenous species:**
6 (1) **The diversity or abundance of native species.**
7 (2) **The ecological stability of the waters.**
8 (3) **Any of the following types of activities dependent on the**
9 **waters:**
10 (A) **Commercial.**
11 (B) **Agricultural.**
12 (C) **Aquacultural.**
13 (D) **Recreational.**
14 SECTION 2. IC 13-11-2-16.7 IS ADDED TO THE INDIANA
15 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
16 [EFFECTIVE JULY 1, 2011]: **Sec. 16.7. "Ballast water", for**
17 **purposes of this chapter and IC 13-18-24, means water and**

4 ballast water is carried.

5 SECTION 3. IC 13-11-2-142.8 IS ADDED TO THE INDIANA
6 CODE AS A NEW SECTION TO READ AS FOLLOWS
7 [EFFECTIVE JULY 1, 2011]: **Sec. 142.8. "Oceangoing vessel", for**
8 **purposes of this chapter and IC 13-18-24, means a vessel that**
9 **operates on the Great Lakes or the St. Lawrence waterway after**
10 **operating in waters outside the Great Lakes or the St. Lawrence**
11 **waterway.**

12 SECTION 4. IC 13-11-2-197.8 IS ADDED TO THE INDIANA
13 CODE AS A NEW SECTION TO READ AS FOLLOWS
14 [EFFECTIVE JULY 1, 2011]: **Sec. 197.8. "Sediment", for purposes**
15 **of IC 13-18-24, means any matter settled out of ballast water in an**
16 **oceangoing vessel.**

17 SECTION 5. IC 13-15-1-2 IS AMENDED TO READ AS
18 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 2. The water pollution
19 control board shall establish requirements for the issuance of permits
20 to control water pollution and atomic radiation, including the
21 following:

- 22 (1) Permits to control or limit the discharge of any contaminants
- 23 into state waters or into a publicly owned treatment works.
- 24 (2) Permits for the construction, installation, or modification of
- 25 facilities, equipment, or devices to control or limit any discharge,
- 26 emission, or disposal of contaminants into the waters of Indiana
- 27 or into a publicly owned treatment works.
- 28 (3) Permits for the operation of facilities, equipment, or devices
- 29 to control or limit the discharge, emission, or disposal of any
- 30 contaminants into the waters of Indiana or into a publicly owned
- 31 treatment works.

32 **(4) Permits under IC 13-18-24-1 for oceangoing vessels.**
33 However, the water pollution control board may not require a permit
34 under subdivision (2) for any facility, equipment, or device
35 constructed, installed, or modified as part of a surface coal mining
36 operation that is operated under a permit issued under IC 14-34.

37 SECTION 6. IC 13-18-24 IS ADDED TO THE INDIANA CODE
38 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
39 JULY 1, 2011]:

40 **Chapter 24. Ballast Water and Sediment in Oceangoing Vessels**
41 **Sec. 1. Beginning July 1, 2012, each oceangoing vessel engaging**
42 **in port operations in Indiana must obtain a permit from the**

1 department. The department shall issue a permit for an oceangoing
 2 vessel under this section only if the applicant can demonstrate that:
 3 (1) the oceangoing vessel will not discharge aquatic nuisance
 4 species; or
 5 (2) if the oceangoing vessel discharges ballast water or
 6 sediment, that the operator of the vessel will use
 7 environmentally sound technology and methods, as
 8 determined by the department, that can be used to prevent the
 9 discharge of aquatic nuisance species.

10 Sec. 2. Before July 1, 2012, the department shall determine the
 11 requirements for application for and issuance of a permit under
 12 section 1 of this chapter.

13 Sec. 3. The department shall establish a ballast water and
 14 sediment inspection program that ensures that aquatic nuisance
 15 species do not enter the waters of Indiana through the direct or
 16 indirect discharge of either of the following:
 17 (1) Ballast water.
 18 (2) Sediment.

19 Sec. 4. (a) The water pollution control board:
 20 (1) before July 1, 2012, shall adopt rules to implement this
 21 chapter; and
 22 (2) may establish a fee under IC 13-16-1 for the issuance of a
 23 permit under section 1 of this chapter.

24 (b) In adopting rules under subsection (a)(1), the water pollution
 25 control board shall cooperate to the fullest extent practical with:
 26 (1) other Great Lakes basin states;
 27 (2) the Canadian Great Lakes provinces;
 28 (3) the Great Lakes panel on aquatic nuisance species;
 29 (4) the Great Lakes fishery commission;
 30 (5) the International Joint Commission; and
 31 (6) the Great Lakes Commission;

32 to ensure the development of standards for the control of aquatic
 33 nuisance species that are broadly protective of Indiana waters and
 34 other natural resources.
