DIGEST OF INTRODUCED BILL

Citations Affected: IC 10-17-1-4; IC 10-17-9-20.

Synopsis: Veterans' home. Transfers the duties of the Indiana Veterans' Home advisory committee to the Indiana veterans' affairs commission. Repeals a provision that establishes the Indiana Veterans' Home advisory committee.

Effective: Upon passage; July 1, 2011.

A BILL FOR AN ACT to amend the Indiana Code concerning veterans' affairs.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 10-17-1-4 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2011]: Sec. 4. The commission may
3 do acts necessary or reasonably incident to the fulfillment of the
4 purposes of this chapter, including the following:

- 5 (1) Adopt rules under IC 4-22-2 to administer this chapter.
- 6 (2) Advise the veterans' state service officer in problems
- 7 concerning the welfare of veterans.
- 8 (3) Determine general administrative policies within the
- 9 department.
- 10 **(4) Advise the director and the superintendent of the Indiana**
- 11 **Veterans' Home of ways to improve the Indiana Veterans'**
- 12 **Home and the care of its residents.**

13 SECTION 2. IC 10-17-9-20 IS REPEALED [EFFECTIVE JULY 1,
14 2011].

15 SECTION 3. [EFFECTIVE UPON PASSAGE] **(a) The terms of**
16 **members of the Indiana Veterans' Home advisory committee**
17 **established by IC 10-17-9-20 who are serving on June 30, 2011,**



1 **expire June 30, 2011.**
2 **(b) This SECTION expires January 1, 2012.**
3 **SECTION 4. An emergency is declared for this act.**
