

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 30 be amended to read as follows:

1           Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3           "SECTION 1. IC 21-17-5-5, AS ADDED BY P.L.2-2007, SECTION  
4 258, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY  
5 1, 2011]: Sec. 5. (a) **This section applies only to a police officer who**  
6 **meets the minimum basic training and educational requirements**  
7 **adopted by the law enforcement training board under IC 5-2-1-9**  
8 **as necessary for employment as a law enforcement officer.**  
9           (b) **Except as provided in subsection (b),** A police officer appointed  
10 under this chapter may exercise the powers granted under this chapter  
11 ~~only~~ upon any real property owned or occupied by the educational  
12 institution employing the police officer, including the streets passing  
13 through and adjacent to the educational institution. **An institution may**  
14 **extend a police officer's territorial jurisdiction in accordance with**  
15 **subsection (c).**  
16           (c) **An institution may extend a police officer's territorial**  
17 **jurisdiction to the entire state, or to any part of the state, if:**  
18           (1) **the board of trustees adopts a resolution specifically**  
19 **describing the territorial jurisdiction of a police officer**  
20 **appointed under this chapter; and**  
21           (2) **the board of trustees notifies the:**  
22           (A) **superintendent of the state police department; and**  
23           (B) **sheriff of the county in which the institution is**  
24 **primarily located (or the chief of police of the consolidated**  
25 **city, if the institution is primarily located in a consolidated**  
26 **city);**  
27           **of the boundaries of the extended territorial jurisdiction.**  
28 **The institution shall provide the persons described in subdivision**  
29 **(2)(A) and (2)(B) with notice of the extended jurisdiction every two**  
30 **(2) years, by January 31 of the second year.**

1           **(d) If a police officer appointed under this section exercises the**  
2 **officer's police powers outside the county in which the institution**  
3 **is primarily located, the officer shall notify the sheriff (or, in the**  
4 **case of a consolidated city, the chief of police) as soon as**  
5 **practicable.**

6           (b) Additional jurisdiction may be established by agreement with  
7 the chief of police of the municipality or sheriff of the county or the  
8 appropriate law enforcement agency where the educational institution's  
9 property is located, depending upon the jurisdiction involved."

10           Page 1, line 3, after "6." insert "(a)".

11           Page 1, line 4, after "chapter" delete ":" and insert "as follows:".

12           Page 1, line 5, after "(1)" insert "A police officer may exercise the  
13 **officer's powers**".

14           Page 1, line 7, delete "institution;" and insert "institution.".

15           Page 1, line 11, delete "and".

16           Page 1, delete lines 12 through 17, begin a new line block indented  
17 and insert:

18           **"(2) This subdivision applies only to a police officer who meets**  
19 **the minimum basic training and educational requirements**  
20 **adopted by the law enforcement training board under**  
21 **IC 5-2-1-9 as necessary for employment as a law enforcement**  
22 **officer. An institution may extend a police officer's territorial**  
23 **jurisdiction to the entire state, or to any part of the state, if:**

24           **(A) the board of trustees adopts a resolution specifically**  
25 **describing the territorial jurisdiction of a police officer**  
26 **appointed under this chapter; and**

27           **(B) the board of trustees notifies the:**

- 28           **(i) superintendent of the state police department; and**
- 29           **(ii) sheriff of the county in which the institution is**  
30 **primarily located (or the chief of police of the**  
31 **consolidated city, if the institution is primarily located in**  
32 **a consolidated city);**

33           **of the boundaries of the extended territorial jurisdiction.**

34           **The institution shall provide the persons described in clause**  
35 **(B)(i) and (B)(ii) with notice of the extended jurisdiction every**  
36 **two (2) years, by January 31 of the second year.**

37           **(b) If a police officer appointed under this section exercises the**  
38 **officer's police powers outside the county in which the institution**  
39 **is primarily located, the officer shall notify the sheriff (or, in the**

1 **case of a consolidated city, the chief of police) as soon as**  
2 **practicable."**

3 Delete page 2.

4 Renumber all SECTIONS consecutively.
