**I move** that Senate Bill 178 be amended to read as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT concerning insurance.
- 3 Page 1, delete lines 1 through 17.
- 4 Delete pages 2 through 7.
- 5 Page 8, delete lines 1 through 11.
- 6 Page 8, line 12, delete "A NEW CHAPTER TO READ AS
- 7 FOLLOWS", begin a new paragraph and insert:
- 8 "SECTION 1."
- 9 Page 8, delete lines 13 through 14.
- 10 Page 8, line 15, delete "Sec. 1." and insert "1, 2011] (a)".
- 11 Page 8, line 15, delete "chapter," and insert "**SECTION, "enrollee"**
- 12 **has the meaning set forth in IC 27-13-1-12.**
- 13 **(b) As used in this SECTION, "health maintenance**
- 14 **organization" has the meaning set forth in IC 27-13-1-19. The term**
- 15 **includes a pharmacy benefit manager.**
- 16 **(c) As used in this SECTION,**

- 23 **SECTION, "subscriber" has the meaning set forth in**
- 24 **IC 27-13-1-32.**
- 25 **(g)**".
- 26 Page 8, line 23, delete "chapter," and insert "**SECTION,**".
- 27 Page 8, line 25, after "insured's" insert "**or enrollee's**".
- 28 Page 8, delete lines 27 through 28, begin a new paragraph and
- 29 insert:
- 30 **"(h) The health finance commission established by IC 2-5-23-3**

- 1       **shall, during the 2011 interim of the general assembly, study the**  
2       **following possible prohibitions on insurers and health maintenance**  
3       **organizations related to outpatient benefits:".**  
4       Page 8, line 29, delete "Request" and insert "**Requesting**".  
5       Page 8, line 29, after "insured's" insert "**or enrollee's**".  
6       Page 8, line 31, delete "Contact" and insert "**Contacting**".  
7       Page 8, line 31, after "insured" insert "**, enrollee, or subscriber**".  
8       Page 8, line 32, delete "Request" and insert "**Requesting**".  
9       Page 8, line 32, after "insured's" insert "**or enrollee's**".  
10      Page 8, delete lines 36 through 42, begin a new paragraph and  
11      insert:  
12      "**(i) This SECTION expires December 31, 2011.**".  
13      Delete page 9.  
14      Renumber all SECTIONS consecutively.
