

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 575 be amended to read as follows:

- 1 Replace the effective dates in SECTIONS 1 through 19 with
2 "[EFFECTIVE JULY 1, 2012]".
3 Page 1, between the enacting clause and line 1, begin a new
4 paragraph and insert:
5 "SECTION 1. IC 2-5.5-6 IS ADDED TO THE INDIANA CODE AS
6 A **NEW CHAPTER TO READ AS FOLLOWS** [EFFECTIVE UPON
7 PASSAGE]:
8 **Chapter 6. Interim Study Committee on Teacher Collective**
9 **Bargaining**
10 **Sec. 1. As used in this chapter, "committee" refers to the**
11 **interim study committee on teacher collective bargaining**
12 **established by section 2 of this chapter.**
13 **Sec. 2. The interim study committee on teacher collective**
14 **bargaining is established.**
15 **Sec. 3. The committee consists of eleven (11) members appointed**
16 **as follows:**
17 **(1) Two (2) members of the senate not affiliated with the same**
18 **political party, appointed by the president pro tempore of the**
19 **senate in consultation with the minority leader of the senate.**
20 **(2) Two (2) members of the house of representatives not**
21 **affiliated with the same political party, appointed by the**
22 **speaker of the house of representatives in consultation with**
23 **the minority leader of the house of representatives.**
24 **(3) One (1) member who is employed as a teacher in an urban**
25 **school district appointed by the president pro tempore of the**
26 **senate.**
27 **(4) One (1) member who is employed as a teacher in a rural**
28 **school district appointed by the speaker of the house of**
29 **representatives.**

- 1 **(5) One (1) member representing the Indiana School Boards**
 2 **Association.**
- 3 **(6) One (1) member representing the Indiana Association of**
 4 **Public School Superintendents.**
- 5 **(7) One (1) member representing a school employee**
 6 **organization (as defined in IC 20-29-2-14).**
- 7 **(8) One (1) member appointed by the governor.**
- 8 **(9) One (1) member appointed by the state superintendent of**
 9 **public instruction.**
- 10 **Sec. 4. The chairman of the legislative council shall appoint a**
 11 **legislative member of the committee to serve as the chair of the**
 12 **committee.**
- 13 **Sec. 5. The committee shall study the following:**
- 14 **(1) The feasibility of amendments to IC 20-29 made by**
 15 **legislation enacted or proposed during the 2011 session of the**
 16 **general assembly.**
- 17 **(2) Possible causes of struggling schools and the failing of**
 18 **Adequate Yearly Progress (AYP), including the impact of**
 19 **administrative personnel as well as instructors.**
- 20 **(3) Other topics assigned by the legislative council or as**
 21 **directed by the committee chair.**
- 22 **Sec. 6. Before November 1, 2011, the committee shall issue a**
 23 **final report containing the committee's findings and**
 24 **recommendations, including any recommended legislation, to the**
 25 **legislative council.**
- 26 **Sec. 7. This chapter expires December 31, 2011."**
 27 Page 4, line 18, delete "2011," and insert "**2012**,".
- 28 Page 6, line 20, delete "2011," and insert "**2012**,".
- 29 Page 6, line 23, delete "2011." and insert "**2012**,".
- 30 Page 6, line 37, delete "2011," and insert "**2011**,".
- 31 Page 7, line 34, delete "2011," and insert "**2012**,".
- 32 Page 10, after line 35, begin a new paragraph and insert:
 33 "**SECTION 21. An emergency is declared for this act.**"
- 34 Re-number all SECTIONS consecutively.
