MADAM PRESIDENT:

- 6 **Sec. 2. For purposes of this chapter, the performance of the**
- 7 **duties of:**
- 8 **(1) a precinct election officer (as defined in IC 3-5-2-40.1) that**
- 9 **are imposed by IC 3; or**
- 10 **(2) a volunteer firefighter (as defined in IC 36-8-12-2);**
- 11 **is not considered employment by a unit."**
