

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 256 be amended to read as follows:

- 1 Page 3, between lines 27 and 28, begin a new paragraph and insert:
2 "SECTION 10. IC 2-1-9-12 IS ADDED TO THE INDIANA CODE
3 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**
4 **UPON PASSAGE]: (a) As used in this section, "redistricting act"**
5 **refers to any act that enacted IC 2-1-12, IC 2-13-13, or both of**
6 **those statutes.**
7 **(b) The provisions of a redistricting act are severable as**
8 **provided in IC 1-1-1-8(b).**
9 **(c) If:**
10 **(1) any portion of a redistricting act, including any district; or**
11 **(2) application of any portion of a redistricting act to any**
12 **person or circumstance;**
13 **is found to be invalid by a court, the invalidity does not affect the**
14 **remaining portions or applications of the redistricting act,**
15 **including the remaining districts, that can be given effect without**
16 **the invalid portions, applications, or districts.**
17 **(d) Redistricting is a state legislative function under both the**
18 **Constitution of the State of Indiana and the Constitution of the**
19 **United States. Therefore, if a redistricting act or any portion of a**
20 **redistricting act is found invalid by a court, the general assembly**
21 **expresses its preference that any court that finds the invalidity give**
22 **the general assembly the opportunity to cure the invalidity before**
23 **the court mandates its own remedial plan. The opportunity to cure**
24 **is without prejudice to the right of either house of the general**
25 **assembly to seek further appeal of any such court action.**
26 **(e) The general assembly reserves the right to replace any**
27 **redistricting plan mandated by a court immediately, if in session**
28 **or, if not in session, in a special session or the next regular session,**
29 **whichever comes first.**
30 **(f) In any court proceeding challenging a redistricting plan of**

- 1 **the general assembly each of the Indiana house of representatives**
2 **or the Indiana senate may:**
- 3 **(1) take independent legal positions in the proceeding; and**
4 **(2) hire independent legal counsel to represent their respective**
5 **legal positions.**
- 6 **The speaker of the house of representatives shall determine the**
7 **legal position taken by the house of representatives. The president**
8 **pro tempore of the senate shall determine the legal position taken**
9 **by the senate."**
