Synopsis: Hoosier commission for communities for a lifetime. Creates the Hoosier commission for communities for a lifetime. Requires the commission to submit certain reports to the general assembly. (The introduced version of this bill was prepared by the health finance commission.)

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 2. IC 12-7-2-37.5 IS ADDED TO THE INDIANA CODE AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 37.5. "Community for a lifetime", for purposes of IC 12-10-2.5, has the meaning set forth in IC 12-10-2.5-2.**

SECTION 3. IC 12-10-2.5 IS ADDED TO THE INDIANA CODE AS A **NEW CHAPTER** TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]:

Chapter 2.5. Hoosier Commission for Communities for a Lifetime

Sec. 1. As used in this chapter, "commission" refers to the Hoosier commission for communities for a lifetime established by section 3 of this chapter.

Sec. 2. As used in this chapter, "community for a lifetime" refers to a community where residents work together in holistic and multidisciplinary ways to allow residents to:

- (1) organize and become involved in the community;
- (2) decide collectively on the priorities for the community; and
- (3) act on the priorities to implement change in the community.

Sec. 3. (a) The Hoosier commission for communities for a lifetime is established to report to the general assembly with recommendations on the following:

- (1) A process for a community to request and receive the designation of Hoosier community for a lifetime.
- (2) The resources needed, from all sectors, to:
 - (A) initiate planning; and
 - (B) implement plans;
 in a community to become a community for a lifetime.

(b) The commission consists of the following members to be appointed for a term ending December 31, 2012:

- (1) The executive director of the Indiana housing and community development authority created by IC 5-20-1-3, or the executive director's designee, who shall serve as the chairperson of the commission.
- (2) The director of the division of aging established by IC 12-9.1-1-1, or the director's designee.
- (3) Two (2) city officials, to be appointed as follows:
 - (A) One (1) city official to be appointed by the minority leader of the senate.

 - 17 **(18) One (1) representative of the Indiana community**
 - 18 **foundation network, to be appointed by the governor.**
 - 19 **(c) The commission shall be staffed by the Indiana housing and**
 - 20 **community development authority. Expenses of the commission**
 - 21 **shall be paid from appropriations made to the Indiana housing and**
 - 22 **community development authority.**
 - 23 **Sec. 4. A member of the commission is not entitled to per diem**
 - 24 **or travel expenses incurred in attending commission meetings.**
 - 25 **Sec. 5. The affirmative votes of a majority of the voting**
 - 26 **members appointed to the commission are required for the**
 - 27 **commission to take action on any measure, including preliminary**
 - 28 **and final reports.**
 - 29 **Sec. 6. (a) When developing a plan for a community to become**
 - 30 **a community for a lifetime, the commission shall consider the**
 - 31 **following criteria:**
 - 32 **(1) Affordable housing.**
 - 33 **(2) Housing that is modified and constructed to accommodate**
 - 34 **mobility issues and safety.**
 - 35 **(3) Livability and safety, including a walkable environment**
 - 36 **and complete streets.**
 - 37 **(4) Access to nutritious food.**
 - 38 **(5) Access to economic and wealth building opportunities.**
 - 39 **(6) Home care and personal assistance services that residents**
 - 40 **know how to obtain.**
 - 41 **(7) Available retail services.**
 - 42 **(8) Access to preventive health care.**

- 1 **(9) Opportunities for physical activity.**
- 2 **(10) Access to medical care.**
- 3 **(11) Access to affordable transportation.**
- 4 **(12) Available community services system.**
- 5 **(13) Mobilized caregivers to complement the formal service**
- 6 **system.**
- 7 **(14) Access to quality community or senior centers, nursing**
- 8 **homes, assisted living facilities, adult day care, and adult**
- 9 **foster care.**
- 10 **(15) Promotion of social and civic engagement.**
- 11 **(16) Access to meaningful relationships with children and**
- 12 **youth in the community.**

13 **(b) The commission shall consult with the Indiana Institute on**
 14 **Disability and Community's Center on Aging and Community to**
 15 **achieve the goals of the commission.**

16 **Sec. 7. A community for a lifetime must do the following:**

- 17 **(1) Involve partnerships among the state, regions, counties,**
- 18 **municipalities, cities, and towns where citizens seek to**
- 19 **affirmatively provide a high quality of life for all residents**
- 20 **and extend the opportunities, support, and services that will**
- 21 **enable citizens to grow older in a community of choice and to**
- 22 **continue to be contributing, civically engaged residents.**
- 23 **(2) Incorporate widespread citizen participation methods into**
- 24 **the local planning process.**
- 25 **(3) Establish an ongoing local commission to advise the**
- 26 **community on the opportunities, services, and supports**
- 27 **required by the citizens.**
- 28 **(4) Incorporate into the local plan elements addressing the**
- 29 **impact of changes in population demographics, including age,**
- 30 **land use, housing, public facilities, transportation, and capital**
- 31 **improvement.**
- 32 **(5) Develop strategies to develop infrastructure needed for the**
- 33 **projected population.**

34 **Sec. 8. The commission shall make a preliminary report to the**
 35 **general assembly not later than November 1, 2011. The commission**
 36 **shall make a final report to the general assembly not later than**
 37 **November 1, 2012. The reports to the general assembly must be in**
 38 **an electronic format under IC 5-14-6.**

39 **Sec. 9. This chapter expires December 31, 2012.**

40 **SECTION 4. An emergency is declared for this act.**
