DIGEST OF SB 256 (Updated April 14, 2011 6:10 pm - DI 102)

Citations Affected: IC 2-1; IC 3-11.

Synopsis: Updates date references in the statute establishing general technical provisions relating to legislative redistricting. Establishes the 2011 Indiana senate district plan. Requires the office of census data, not later than July 1, 2011, to file with the election division description information for a precinct established before January 1, 2011. Requires the election division to immediately notify each county executive and county election board (or board of elections and registration) that the filing has occurred. Requires the county executive to submit to the election division, not later than January 1, 2012, additional information for or corrections to the filing, which will become the precinct boundaries for the county, or to notify the election division that the

county executive will establish precincts by preparing a new precinct establishment order. Provides that the precinct descriptions filed by the office of census data are the descriptions the county must use for elections conducted after January 1, 2012, if the county executive does not notify the election division otherwise, and prohibits objections to those precinct descriptions. Requires a county executive to correct and file with the election division not later than January 1, 2012, any IEC-8 submitted before January 1, 2011, that contains incorrect information as the result of the 2011 congressional or legislative district plans. Provides that this process does not prohibit a county executive from establishing precincts using a precinct establishment order. Repeals the 2001 senate district plan.

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

Be it enacted by the General Assembly of the State of Indiana:

16 (1) is contiguous to the part; and

17 (2) contains the least population of all house or senate districts

18 contiguous to that part according to the ~~2000~~ **2010** decennial

19 census of Indiana.

20 (b) If any part of Indiana is described as being in more than one (1)

21 house or senate district, the part is included within the house or senate

22 district that:

23 (1) is one (1) of the house or senate districts in which the part is

24 listed in ~~IC 2-1-10~~ **IC 2-1-12** or ~~IC 2-1-11~~ **IC 2-1-13**, whichever

25 is applicable;

26 (2) is contiguous to the part; and

27 (3) contains the least population according to the 2000 decennial

28 census of Indiana.

29 (c) If any part of Indiana:

30 (1) is described in ~~IC 2-1-10~~ **IC 2-1-12** or ~~IC 2-1-11~~ **IC 2-1-13** as

31 being in one (1) house or senate district; and

32 (2) entirely surrounded by another house or senate district;

33 the part shall be incorporated into the house or senate district that

34 surrounds the part.

35 (d) If any part of Indiana:

36 (1) is described as being in one (1) house or senate district; and

37 (2) is not contiguous to another part of the house or senate district

38 that contains the majority of the population in the house or senate

39 district;

40 the part is included with the contiguous house or senate district that

41 contains the least population according to the ~~2000~~ **2010** decennial

1 SECTION 6. IC 2-1-9-8 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2011]: Sec. 8. Indiana is divided into one

4 From each of these districts there shall be elected one (1)

15 shall represent the district established under ~~IC 2-1-11~~ **IC 2-1-13** in
16 which the senator's legal residence is located.

17 SECTION 8. IC 2-1-9-10 IS AMENDED TO READ AS FOLLOWS
18 [EFFECTIVE JULY 1, 2011]: Sec. 10. The legislative services agency
19 shall separately maintain and preserve in the GIS the descriptions and
20 maps included in the ~~2000~~ **2010** decennial census of Indiana. The
21 legislative services agency shall make those descriptions and maps
22 available for public inspection during regular office hours and on the
23 Internet.

24 SECTION 9. IC 2-1-9-11 IS AMENDED TO READ AS FOLLOWS
25 [EFFECTIVE JULY 1, 2011]: Sec. 11. The official report and all
26 official documents relating to the report of the ~~2000~~ **2010** decennial
27 census are incorporated by reference into this article.
