

CONFERENCE COMMITTEE REPORT DIGEST FOR ESB 537

Synopsis: State museums and historic sites. Conference committee report for ESB 537. State museum and historic sites. Establishes the Indiana state museum and historic sites corporation (corporation) as a public body corporate and politic to govern the state museum and historic sites. Establishes the corporation's board of trustees to oversee and govern the corporation. Provides that the Indiana state museum and historic sites corporation board of trustees are exempt from the state procurement requirements. Makes meetings of the board subject to the open meetings law and makes records of the corporation subject to the open records law. Provides an exception from the procurement statutes for the board's acquisition of artifacts for the state museum and historic sites. Provides that employees of the corporation are subject to the state personnel system and participation in the public employees' retirement fund. Provides that the corporation is subject to the state personnel system. Permits the corporation's employees to participate in the state employee group insurance and other benefit plans. Provides that the board and corporation employees are under the jurisdiction of the ethics commission and the executive branch ethics rules. Specifies that the corporation's proposed budget is subject to the budget statutes governing state agencies if the proposed budget includes funding from the state general fund. Establishes the state museum and historic sites development fund. Provides that the board's investments must be consistent with the public funds investment requirements that apply to the treasurer of state. Provides that interest earned on the corporation's investments shall be deposited in the corporation's funds. Provides that all earned income accruing to the corporation's fund is appropriated continuously. Requires the chief executive officer of the corporation to report annually to the state budget committee concerning the activities, revenues, expenditures, and profits of the museums' shops, facility rentals, and restaurants. Requires the executive officer of the corporation to enter into a memorandum of understanding with nonprofit organizations that are recognized supporters of state historic site. Requires the executive officer of the corporation to enter into a memorandum of understanding with: (1) the Indiana department of transportation; (2) the department of correction; and (3) the department of natural resources (DNR). Establishes the state museum foundation. Includes transitional provisions to transfer the museum and historic sites functions and funds from the DNR to the corporation. Requires prior review of the state

budget committee and the approval of the budget director for obligations to be incurred by the corporation for lands and structures. Repeals laws governing the state museum and historic sites as entities administered by the DNR. Makes conforming changes. **(This conference committee report: (1) removes and amends various provisions concerning personnel matters of the Indiana state museum and historic sites corporation; and (2) makes technical and conforming changes.)**

- 8 **ARTICLE 37. STATE MUSEUM AND HISTORIC SITES**
- 9 **Chapter 1. Definitions**
- 10 **Sec. 1. Except as otherwise provided, the definitions in this**
- 11 **chapter apply throughout this article.**
- 12 **Sec. 2. "Board" refers to the corporation's board of trustees**
- 13 **established by IC 4-37-3-1.**
- 14 **Sec. 3. "Chief executive officer" refers to the chief executive**
- 15 **officer of the Indiana state museum and historic sites corporation**
- 16 **appointed under IC 4-37-2-5 and the director of the state museum.**
- 17 **Sec. 4. "Corporation" refers to the Indiana state museum and**
- 18 **historic sites corporation established by IC 4-37-2-1.**
- 19 **Sec. 5. "Foundation" refers to the Indiana state museum**
- 20 **foundation established under IC 4-37-8-1 or its successors.**
- 21 **Sec. 6. "Fund" refers to the state museum and historic sites**

1 development fund established by IC 4-37-7-1.

2 Sec. 7. "Historic site" refers to a state historic site established
3 and maintained by the board under the criteria established by the
4 board.

5 Sec. 8. "Museum" refers to the state museum.

6 Sec. 9. "State museums" refers to the following:

7 (1) The state museum located in the White River State Park.

8 (2) The historic sites.

9 Chapter 2. State Museum and Historic Sites Corporation

10 Sec. 1. The Indiana state museum and historic sites corporation
11 is established.

12 Sec. 2. (a) The corporation is:

13 (1) a public body corporate and politic; and

14 (2) an instrumentality of the state.

15 (b) The corporation is separate from the state. However, the
16 exercise by the corporation of its powers is an essential
17 governmental function.

18 Sec. 3. The corporation may:

19 (1) sue and be sued; and

20 (2) plead and be impleaded.

21 Sec. 4. The corporation is subject to a biennial audit by the state
22 board of accounts.

23 Sec. 5. The board shall appoint, subject to the governor's
24 approval, an individual to serve as chief executive officer of the
25 corporation.

26 Sec. 6. The corporation is not subject to the requirements under
27 IC 5-13-6-1.

28 Sec. 7. The records of the corporation are subject to IC 5-14-3.

29 Sec. 8. (a) After June 30, 2011, rules that concern the division of
30 state museums and historic sites that were adopted by the natural
31 resources commission shall be treated as rules applying to the
32 corporation.

33 (b) After June 30, 2011, a reference to the department of natural
34 resources in a statute or rule concerning the division of state
35 museums and historic sites shall be treated as a reference to the
36 corporation.

37 Chapter 3. Members and Organization

38 Sec. 1. The corporation is governed by a board of trustees that
39 consists of the following members:

40 (1) Thirteen (13) persons appointed by the governor who are
41 voting members. The governor's appointments must meet the
42 following criteria:

43 (A) Each member must be a resident of Indiana.

44 (B) Not more than two (2) members may reside in the same
45 county.

46 (C) At least one (1) member must be a recognized
47 supporter of historic sites.

48 (D) Not more than seven (7) members may be from the
49 same political party.

50 (2) Twelve (12) persons appointed by the board who are
51 voting members. The board's appointments must meet the

1 following criteria:

2 (A) Each member must be a resident of Indiana.

3 (B) Not more than two (2) members may reside in the same
4 county.

5 (C) At least one (1) member must be a recognized
6 supporter of historic sites.

7 (D) Not more than six (6) members may be from the same
8 political party.

9 (3) The following persons serve as nonvoting members of the
10 board:

11 (A) The chief executive officer.

12 (B) The governor or the governor's designee.

13 (C) One (1) member of the house of representatives
14 appointed by the chairman of the legislative council.

15 (D) One (1) member of the senate appointed by the
16 chairman of the legislative council.

17 (E) The director of the department of natural resources or
18 the director's designee.

19 The members appointed under clauses (C) and (D) must be
20 from different political parties and serve at the pleasure of the
21 chairman of the legislative council.

22 Sec. 2. (a) The members appointed in section 1 of this chapter:

23 (1) begin their terms July 1;

24 (2) shall serve for terms of three (3) years; and

25 (3) may be reappointed or replaced by the appointing
26 authority, but may not serve more than three (3) consecutive
27 terms.

28 (b) A member appointed under this section to fill a vacancy shall
29 fill the vacancy for the remainder of the unexpired term.

30 (c) Each member shall continue to serve until the member's
31 successor is appointed and qualified.

32 Sec. 3. (a) The governor shall appoint the chair of the board,
33 who shall serve for a one (1) year term or until the governor
34 appoints a successor.

35 (b) The board shall elect a vice chair, secretary, and treasurer
36 for a term of two (2) years each.

37 Sec. 4. (a) Thirteen (13) voting members of the board constitute
38 a quorum.

39 (b) The board shall adopt bylaws establishing procedures for the
40 board.

41 Sec. 5. Board members are not liable in an individual capacity
42 for any act done or omitted in connection with the performance of
43 duties under this article. This section does not apply to an act or
44 omission that constitutes gross negligence or willful misconduct.

45 Sec. 6. (a) Each member of the board who is not a state
46 employee is entitled to the minimum salary per diem provided by
47 IC 4-10-11-2.1(b). The member is also entitled to reimbursement
48 for traveling expenses as provided under IC 4-13-1-4 and for other
49 expenses actually incurred in connection with the member's duties
50 as provided in the state policies and procedures established by the
51 Indiana department of administration and approved by the budget

1 agency.

2 (b) Each member of the board who is a state employee but who
3 is not a member of the general assembly is entitled to
4 reimbursement for traveling expenses as provided under
5 IC 4-13-1-4 and for other expenses actually incurred in connection
6 with the member's duties as provided in the state policies and
7 procedures established by the Indiana department of
8 administration and approved by the budget agency.

9 (c) Each member of the board who is a member of the general
10 assembly is entitled to receive the same per diem, mileage, and
11 travel allowances paid to legislative members of interim study
12 committees established by the legislative council. Per diem,
13 mileage, and travel allowances paid under this subsection shall be
14 paid from appropriations made to the legislative council or the
15 legislative services agency.

16 **Chapter 4. General Powers, Duties, and Exemptions**

17 **Sec. 1. The title to the following shall be held in the name of the**
18 **state of Indiana:**

19 (1) Property constituting the state museums, except to the
20 extent that the property is subject to a use and occupancy
21 agreement between the Indiana finance authority and the
22 Indiana department of administration.

23 (2) Property acquired by the board.

24 **Sec. 2. The board shall do the following:**

25 (1) Operate and administer the state museums.

26 (2) Maintain accreditation of the state museums.

27 (3) Collect, preserve, display, and interpret artifacts and
28 materials reflecting the cultural and natural history of
29 Indiana.

30 (4) Prepare and maintain a statewide inventory of the
31 artifacts and materials described in subdivision (3).

32 (5) Uphold the highest professional and ethical standards, as
33 adopted by the American Association of Museums.

34 **Sec. 3. The board may do the following:**

35 (1) Do any and all acts and things necessary, proper, or
36 convenient to carry out this article.

37 (2) Hold meetings under IC 5-14-1.5 at the times and places in
38 Indiana that are prescribed by the board's bylaws.

39 (3) Adopt an official seal.

40 (4) Adopt bylaws.

41 (5) Make and execute contracts and other instruments
42 necessary or convenient to the exercise of the board's powers.

43 (6) Acquire by grant, purchase, gift, devise, or lease or
44 otherwise and hold, use, sell, lease, manage, operate, clear,
45 improve, encumber, transfer, convey, exchange, or dispose of
46 the following:

47 (A) Real and personal property and any interest in real or
48 personal property.

49 (B) Facilities.

50 (C) Money or stocks.

51 (D) Any right or interest necessary or useful for carrying

- 1 out the board's powers and duties under this article.
- 2 (7) Procure insurance against any loss in connection with the
3 board's operations.
- 4 (8) Enter into contractual or other arrangements with the
5 Indiana department of administration in connection with the
6 financing of the state museums under IC 4-13.5.
- 7 (9) Notwithstanding IC 4-13.5-4-5, allocate space in museums
8 financed by the Indiana finance authority under IC 4-13.5.
- 9 (10) Fix and collect rents, admission charges, fees, tolls, and
10 other user charges for:
- 11 (A) the state museums;
- 12 (B) restaurants;
- 13 (C) other facilities; and
- 14 (D) programs, lectures, classes, tours, and trips.
- 15 (11) Maintain shops and restaurants on property that the
16 board manages and at other locations and employ or contract
17 with persons to manage the shops and restaurants.
- 18 (12) Make or sell the following:
- 19 (A) Pictures, models, books, and other representations of
20 the museum and its artifacts and exhibits.
- 21 (B) Souvenirs, crafts, art, videotapes, digital video discs,
22 and other merchandise.
- 23 (13) Pay royalties, license fees, or charges for exhibits,
24 artifacts, artwork, or materials.
- 25 (14) Own copyrights, trademarks, and service marks and
26 enforce the board's rights with respect to ownership.
- 27 (15) Conduct market research concerning the state museums.
- 28 (16) Adopt rules under IC 4-22-2 to carry out the purposes of
29 this article.
- 30 **Sec. 4. (a) The board may accept or refuse to accept an offered**
31 **gift of historic property to be administered by the board.**
- 32 **(b) Notwithstanding IC 4-20.5-7 and IC 5-22-22, the board may**
33 **sell, lease, or exchange historic property administered by the**
34 **board.**
- 35 **(c) Notwithstanding IC 5-22-22, the board may, in accordance**
36 **with the board's policies, sell, donate, or exchange artifacts in the**
37 **state museums' collections to or with other public or nonprofit**
38 **museums or historical societies.**
- 39 **(d) The board may by rule establish a procedure for evaluating**
40 **the merits of proposals to:**
- 41 **(1) accept gifts of;**
- 42 **(2) sell; or**
- 43 **(3) exchange;**
- 44 **artifacts or historic property.**
- 45 **(e) The board may donate or make short term loans of artifacts**
46 **in the museums' collections to other:**
- 47 **(1) public or nonprofit museums; or**
- 48 **(2) historical societies.**
- 49 **Sec. 5. The board is not required to pay any taxes or**
50 **assessments upon any property acquired or used by the board**
51 **under this article, or upon the income from the property.**

1 **Sec. 6. The board is exempt under IC 6-2.5-5-16 from the state**
 2 **gross retail tax for transactions involving tangible personal**
 3 **property, public utility commodities, and public utility service.**

4 **Sec. 7. The board is exempt from the following:**

5 **(1) The requirements of IC 4-13-2-20 prohibiting payment in**
 6 **advance.**

7 **(2) The procurement requirements under IC 5-22.**

8 **Sec. 8. (a) The board shall annually evaluate the performance of**
 9 **the chief executive officer.**

10 **(b) Subject to approval by the governor, the board may dismiss**
 11 **the chief executive officer.**

12 **Chapter 5. Personnel Matters**

13 **Sec. 1. Employees of the corporation are not employees of the**
 14 **state.**

15 **Sec. 2. The board shall do the following:**

16 **(1) Establish policies for the governance and management of**
 17 **the staffs of the state museums.**

18 **(2) Establish the rights and duties of corporation employees,**
 19 **including a pay scale and benefit package.**

20 **(3) Employ or contract with consultants, attorneys, or other**
 21 **persons as are required in the judgment of the board and pay**
 22 **compensation from funds available to the board.**

23 **Sec. 3. The board may develop a separate personnel system for**
 24 **employees of the corporation. The system may establish the rights,**
 25 **privileges, powers, and duties of the corporation employees,**
 26 **including pay scale and benefit package. If the board does not**
 27 **develop and adopt a personnel system, the employees of the**
 28 **corporation are subject to the state personnel system under**
 29 **IC 4-15-1.8. If the board does adopt a separate personnel system,**
 30 **the rules should mirror the state personnel rules as closely as**
 31 **possible.**

32 **Sec. 4. (a) The board shall adopt a resolution providing that the**
 33 **corporation's employees who are eligible to participate in the**
 34 **public employees' retirement fund under the eligibility**
 35 **requirements set forth in IC 5-10.2 and IC 5-10.3 shall participate**
 36 **in the fund.**

37 **(b) The board shall adopt a resolution to allow the corporation's**
 38 **employees to participate in group insurance and other benefit**
 39 **plans, including the state employees' deferred compensation plan,**
 40 **that are available to state employees.**

41 **Sec. 5. (a) The board may hire, fix the compensation of, review**
 42 **the performance of, and dismiss, subject to the governor's**
 43 **approval, a chief executive officer who:**

44 **(1) is the director of state museums;**

45 **(2) is the chief administrative officer of the corporation; and**

46 **(3) supervises and directs the work of the state museums'**
 47 **staffs and contractors.**

48 **(b) The chief executive officer may hire, fix the compensation of,**
 49 **review the performance of, and dismiss employees of the**
 50 **corporation.**

51 **Sec. 6. The board and the employees of the corporation are:**

- 1 (1) under the jurisdiction of and rules adopted by the state
 2 ethics commission; and
 3 (2) subject to ethics rules and requirements that apply to the
 4 executive branch of state government.

5 However, the board may adopt additional ethics rules and
 6 requirements that are more stringent than those adopted by the
 7 state ethics commission.

8 Sec. 7. The board may assist in the professional development of
 9 the museums' staffs.

10 Chapter 6. Budget, Finance, and Planning

11 Sec. 1. (a) The chief executive officer shall annually present to
 12 the board the needs and requests of the corporation and a
 13 proposed budget.

14 (b) The chief executive officer shall present the proposed
 15 biennial and board approved annual budget of the corporation to
 16 the governor. The proposed budget is subject to IC 4-12-1 if the
 17 proposed budget includes funding to be appropriated from the
 18 state general fund.

19 Sec. 2. The board may qualify the museum for federal and other
 20 aid to preserve historic property, materials, items, and memorials.

21 Chapter 7. State Museum and Historic Sites Development Fund

22 Sec. 1. The state museum and historic sites development fund is
 23 established. The corporation or an entity designated by the board
 24 shall administer the fund.

25 Sec. 2. The corporation may invest the money in the fund not
 26 currently needed to meet the obligations of the fund in a manner
 27 consistent with IC 5-13-10. Interest earned on the investments shall
 28 be deposited in the corporation's funds.

29 Sec. 3. The expenses of administering the fund shall be paid
 30 from the fund.

31 Sec. 4. The corporation may spend the money in the fund for
 32 any purpose of the corporation that complies with this article,
 33 including the acquisition of real property and historical artifacts
 34 and specimens, construction of facilities, and betterments and
 35 improvements at historic sites.

36 Sec. 5. Except as provided in section 8 of this chapter, the
 37 following shall be deposited in the fund:

- 38 (1) Proceeds from admission and user fees.
 39 (2) Sales at museum shops.
 40 (3) Facility rentals.
 41 (4) Restaurant sales.
 42 (5) Any other income generated by the state museums.
 43 (6) Gifts of money or the proceeds from the sale of gifts
 44 donated to the state museums.

45 Sec. 6. (a) All earned income accruing to the fund is
 46 appropriated continuously for purposes of this article.

47 (b) Money in the fund at the end of a state fiscal year does not
 48 revert to the state general fund.

49 Sec. 7. The chief executive officer shall report annually to the
 50 board and the budget committee on the activities, revenues,
 51 expenditures, and profits of the museums' shops, facility rentals,

1 and restaurants.

2 **Sec. 8.** The chief executive officer of the corporation may enter
3 into a memorandum of understanding with one (1) or more
4 nonprofit organizations that are recognized supporters of a specific
5 state historic site and are exempt from taxation under Section
6 501(c)(3) of the Internal Revenue Code. The memorandum of
7 understanding may provide that the nonprofit organization or
8 organizations may maintain a gift shop and offer special events at
9 the state historic site.

10 **Sec. 9.** The chief executive officer of the corporation shall enter
11 into:

12 (1) a memorandum of understanding with the Indiana
13 department of transportation providing for the Indiana
14 department of transportation to maintain historical services
15 provided to the various state historic sites;

16 (2) a memorandum of understanding with the department of
17 correction providing for the department of correction to
18 provide assistance in maintaining a state historic site; and

19 (3) a memorandum of understanding with the department of
20 natural resources providing for the department of natural
21 resources to provide:

22 (A) assistance or services to repair or clean up a state
23 historic site if a natural disaster or severe weather (as
24 defined in IC 36-8-21.5-7) has occurred; and

25 (B) assistance providing equipment to the state historic
26 sites for special events.

27 **Chapter 8. Indiana State Museum Foundation**

28 **Sec. 1.** The board may establish a nonprofit subsidiary
29 corporation, to be known as the Indiana state museum foundation,
30 that is exempt from federal income taxation under Section
31 501(c)(3) of the Internal Revenue Code to solicit and accept private
32 funding, gifts, donations, bequests, devises, and contributions.

33 **Sec. 2.** The foundation:

34 (1) shall use money received under section 1 of this chapter to
35 carry out in any manner the purposes and programs under
36 this article; and

37 (2) may deposit money received under section 1 of this
38 chapter in an account or fund that is:

39 (A) administered by the foundation; and

40 (B) not part of the state treasury.

41 **Sec. 3.** The foundation is governed by a board of directors. The
42 directors are the members of the board.

43 **Sec. 4.** Employees of the corporation shall provide
44 administrative support for the foundation.

45 **Sec. 5.** The state board of accounts shall annually audit the
46 foundation.

47 **Chapter 9. Governor Frank O'Bannon Great Hall**

48 **Sec. 1.** The museum's great hall shall be known as the
49 "Governor Frank O'Bannon Great Hall".

50 **Sec. 2.** The chief executive officer of the museum shall install
51 and maintain the following:

1 **(1) Appropriate public signage on and around the museum**
 2 **that displays the name of the great hall.**

3 **(2) A plaque located at an appropriate spot in the museum**
 4 **describing the highlights of the life and career of Governor**
 5 **Frank O'Bannon.**

21 according to an allotment schedule under IC 4-13-2-18.

22 (f) This act does not authorize any rehabilitation or repairs to
23 any state buildings, nor does it allow any obligations to be incurred
24 for lands and structures, without the prior review of the budget
25 committee and the approval of the budget director or the director's
26 designee.

27 (g) Notwithstanding IC 4-37-3-2(a)(2), as added by this act, the
28 initial appointments by the governor to the board of trustees of the
29 corporation under IC 4-37-3-2(a) shall be staggered as follows:

30 (1) Four (4) persons appointed by the governor shall be
31 appointed to serve a one (1) year term ending June 30, 2012.

32 (2) Four (4) persons appointed by the governor shall be
33 appointed to serve a two (2) year term ending June 30, 2013.

34 (3) Five (5) persons appointed by the governor shall be
35 appointed to serve a three (3) year term ending June 30, 2014.

36 (h) This SECTION expires July 1, 2013.
