MADAM PRESIDENT:

The Senate Committee on Appropriations, to which was referred Senate Bill No. 537, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning
- 3 natural and cultural resources.
- 4 Page 4, line 39, delete "state office building commission" and insert
- 5 **"Indiana finance authority"**.
- 6 Page 5, line 36, delete "state office building commission" and insert
- 7 **"Indiana finance authority"**.
- 8 Page 7, line 3, after "IC 5-22" delete "." and insert ", **when the**
- 9 **board is acquiring artifacts for the state museum and historic**
- 10 **sites."**
- 11 Page 7, line 10, after "state" delete "." and insert ", **but they are**
- 12 **subject to the state personnel system under IC 4-15-1.8."**
- 13 Page 7, line 11, delete "may" and insert **"shall"**.
- 14 Page 7, line 13, after "museums" insert **"consistent with**
- 15 **IC 4-15-1.8"**.
- 16 Page 7, line 15, after "package" insert **"consistent with**

- 3 Page 7, line 41, after "corporation" delete "." and insert "**, subject**
4 **to state personnel rules and policies.**".
- 5 Page 7, line 42, delete "shall adopt a code of ethics for the" and
6 insert "**and the employees of the corporation are:**
- 7 (1) **under the jurisdiction of and rules adopted by the state**
8 **ethics commission; and**
- 9 (2) **subject to ethics rules and requirements that apply to the**
10 **executive branch of state government.**
- 11 **However, the board may adopt additional ethics rules and**
12 **requirements that are more stringent than those adopted by the**
13 **state ethics commission.**".

- 15 Page 8, line 6, after "shall" insert "**also**".
- 16 Page 8, line 6, delete "the code of ethics" and insert "**any additional**
17 **ethics rules and requirements**".
- 18 Page 8, line 16, after "governor." insert "**The proposed budget is**
19 **subject to IC 4-12-1 if the proposed budget includes funding to be**
20 **appropriated from the state general fund.**".
- 21 Page 8, line 25, delete "policies adopted by the board." and insert
22 "**IC 5-13-10.**".
- 23 Page 8, line 41, delete "(a) All money accruing to the fund is
24 appropriated".
- 25 Page 8, delete line 42.
- 26 Page 9, line 1, delete "(b)".
- 27 Page 8, run in line 41 through page 9, line 1.
- 28 Page 9, line 4, after "board" insert "**and the budget committee**".
- 29 Page 20, line 3, delete "corporation." and insert "**corporation).**".
- 30 Page 20, delete lines 22 through 32, begin a new paragraph and
31 insert:
- 32 "**(d) On July 1, 2011, the budget agency shall determine and**
33 **transfer the available balance of:**
- 34 (1) **the revolving fund of the division of museums and historic**
35 **sites (IC 14-9-5-2);**
- 36 (2) **the state museum development fund (IC 14-20-1-1.5,**
37 **repealed by this act);**
- 38 (3) **the state museum acquisition fund (IC 14-20-1-24,**
39 **repealed by this act); and"**
- 40 Page 20, line 33, delete "(2) money in" and insert "(4)".
- 41 Page 20, between lines 37 and 38, begin a new paragraph and insert:
42 "**(e) The budget agency shall transfer to the corporation**

1 **appropriations for the department of natural resources for the**
2 **period beginning July 1, 2011, and ending June 30, 2013, that were**
3 **intended for the operation and improvement of the state museum**
4 **according to an allotment schedule under IC 4-13-2-18.**

5 **(f) This act does not authorize any rehabilitation or repairs to**
6 **any state buildings, nor does it allow any obligations to be incurred**
7 **for lands and structures, without the prior review of the budget**
8 **committee and the approval of the budget director or the director's**
9 **designee."**

10 Page 20, line 38, delete "(f)" and insert "(g)".

11 Page 21, line 5, delete "(g)" and insert "(h)".
