

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Insurance and Financial Institutions, to which was referred Senate Bill No. 84, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 2, line 5, delete "ninety (90)" and insert "**thirty (30)**".
- 2 Page 2, line 21, delete "ninety (90)" and insert "**thirty (30)**".
- 3 Page 2, line 25, delete "ninety (90)" and insert "**thirty (30)**".
- 4 Page 2, line 30, delete "ninety (90)" and insert "**thirty (30)**".
- 5 Page 2, line 38, delete "agent" and insert "**producer**".
- 6 Page 2, line 39, delete "." and insert "**or an employee or agent of**
- 7 **the producer.**".
- 8 Page 2, line 40, after "carrier" insert "**, or an agent of the insurance**
- 9 **carrier.**".
- 10 Page 3, line 1, delete "insurer" and insert "**insurance carrier**".
- 11 Page 3, line 2, delete "A prosecuting attorney." and insert "**An**
- 12 **attorney who is:**
- 13 **(i) employed by or under contract with the state, a city,**
- 14 **or a county; and**
- 15 **(ii) inspecting or copying the accident report solely for**
- 16 **the business purposes of the state, city, or county.**".
- 17 Page 3, line 5, after "clause" insert "**does**".
- 18 Page 3, between lines 13 and 14, begin a new line double block
- 19 indented and insert:
- 20 "**(G) A nonprofit victim advocacy group whose primary**

1 **purpose includes providing victims with support services**
 2 **at no cost and for no remuneration or monetary**
 3 **consideration. This clause does not include:**
 4 **(i) attorneys or law firms;**
 5 **(ii) medical providers;**
 6 **(iii) telemarketing firms or individuals providing**
 7 **telemarketing services; or**
 8 **(iv) persons who are acting on behalf of or as an agent of**
 9 **any of the persons listed in items (i) through (iii);**
 10 **requesting access to an accident report for the purpose of**
 11 **soliciting accident victims."**

12 Page 3, between lines 15 and 16, begin a new line single block
 13 indented and insert:

14 **"(3) Any local, state, or federal law enforcement agency (as**
 15 **defined in IC 27-2-19-3) or a person under contract with the**
 16 **law enforcement agency to obtain, evaluate, or supply**
 17 **accident reports.**
 18 **(4) A parent, guardian, or custodian of a child if one (1) or**
 19 **more of the following applies:**
 20 **(A) The child resides with a party involved in the accident.**
 21 **(B) A party involved in the accident participates in**
 22 **parenting time with the child under a court order.**
 23 **(C) A party involved in the accident transports the child in**
 24 **connection with a court order."**

25 Page 3, line 17, delete "ninety (90)" and insert "**thirty (30)**".

26 Page 3, line 23, delete "ninety (90)" and insert "**thirty (30)**".

- 1 Page 3, line 36, delete "ninety (90)" and insert "**thirty (30)**".
- 2 Page 4, line 6, delete "ninety (90)" and insert "**thirty (30)**".
- 3 Page 4, line 17, delete "misdemeanor." and insert "**infraction.**".
(Reference is to SB 84 as introduced.)
