

# COMMITTEE REPORT

## MADAM PRESIDENT:

**The Senate Committee on Appropriations, to which was referred Senate Bill No. 340, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:**

- 1           Page 1, line 6, delete "or raffle tickets for a" and insert "**held under**
- 2           **a license issued under IC 4-32.2-4-8, IC 4-32.2-10, or**
- 3           **IC 4-32.2-4-12, or a single event license issued under**
- 4           **IC 4-32.2-4-16; and".**
- 5           Page 1, delete line 7.
- 6           Page 1, line 12, after "30." insert "**(a)**".
- 7           Page 3, line 28, delete "dates and".
- 8           Page 3, line 28, strike "locations" and insert "**days and location**".
- 9           Page 5, line 1, after "the" insert "**reasonable**".
- 10          Page 5, line 2, before "employees" insert "**full-time**".
- 11          Page 7, delete lines 5 through 6, begin a new line block indented
- 12          and insert:
- 13                 **"(1) Prior to using volunteer ticket agents to sell tickets to an**
- 14                 **allowable event, a qualified organization must provide to the**
- 15                 **commission the name, address, and telephone number of the**
- 16                 **general manager of each retail establishment whose**
- 17                 **employees will serve as volunteer ticket agents."**
- 18          Page 7, between lines 12 and 13, begin a new line block indented
- 19          and insert:
- 20                 **"(5) A qualified organization must include on each ticket or**

1 entry sold by a volunteer ticket agent the name of the  
 2 qualified organization, the date of the allowable event, and a  
 3 valid license number for the allowable event.

4 (6) All tickets sold by volunteer ticket agents must be  
 5 numbered sequentially.

6 (7) After tickets to the allowable event are sold, the qualified  
 7 organization shall provide to the commission the name,  
 8 address, and telephone number of each person who served as  
 9 a volunteer ticket agent."

10 Page 7, line 31, delete "IC 4-32.2-4-12." and insert "**IC 4-32.2-4-12,**  
 11 **or a single event license issued under IC 4-32.2-4-16.**".

12 Page 7, line 40, after "IC 4-32.2-4-12" delete "." and insert ", **or a**  
 13 **single event license issued under IC 4-32.2-4-16.**".

14 Page 8, line 7, delete "IC 4-32.2-4-12." and insert "**IC 4-32.2-4-12,**  
 15 **or a single event license issued under IC 4-32.2-4-16.**".

16 Page 8, line 15, delete "lesser of the following:"

17 Page 8, delete lines 16 through 19.

18 Page 8, line 20, delete "(2) The".

19 Page 8, run in lines 15 through 23.

20 Page 9, line 7, delete "IC 4-32.2-4-12." and insert "**IC 4-32.2-4-12,**  
 21 **or a single event license issued under IC 4-32.2-4-16.**".

(Reference is to SB 340 as printed February 14, 2011.)
