ENGROSSED HOUSE BILL No. 1136

DIGEST OF HB 1136 (Updated February 28, 2012 2:56 pm - DI 97)

Citations Affected: IC 12-7; IC 12-17.2.

Synopsis: Child care ministries. Revises the definition of "child care ministry". Requires the division of family resources to establish a child care ministries advisory committee. (The introduced version of this bill was prepared by the committee on child care.)

Effective: July 1, 2012.

Madam President: I move that Engrossed House Bill 1136 be amended to read as follows:

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 12-7-2-28.8 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 28.8. "Child care ministry", for purposes of IC 12-17.2, means child care operated by a church or religious ministry that is a religious organization exempt from federal income taxation under Section 501 of the Internal Revenue Code: that meets all of the following criteria:

- (1) The religious organization has all of the following:
 - (A) A recognized creed and form of worship.
 - (B) Established places of worship.
 - (C) A regular congregation and regular religious services.
- (2) The principal purpose of the religious organization is the study or advancement of religion.
